Provides for information of any negative impact on surrounding parishes to be included in applications for funding of any flood-control projects. (8/1/15)

Present law provides for information to be provided in the application for funding of any flood-control projects under the Statewide Flood Control Program. Proposed law adds to the application requirements that any negative impact of the project on surrounding parishes must be included.
