APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgments in the matters of "James Ronald Fowler, Jr. v. State of Louisiana DOTD" and "Crystal Williams v. State of Louisiana DOTD"

1 AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2012-  
3 2013 to be used to pay the consent judgments in the suit entitled "James Ronald  
4 Fowler, Jr. v. State of Louisiana through the Department of Transportation and  
5 Development" consolidated with "Crystal Williams v. State of Louisiana through the  
6 Department of Transportation and Development" consolidated with "Lois J.  
7 Washington, Individually and on behalf of her minor child, Zilethia Washington and  
8 Betty R. Smith, individually and on behalf of her minor children, Jesse Lewis and  
9 Olajawon Lewis v. Louisiana Department of Transportation and Development"; and  
10 to provide for related matters.

11 Be it enacted by the Legislature of Louisiana:

12 Section 1. The sum of Three Hundred Seventy-Five Thousand Seven-Hundred  
13 Twenty-Five and No/100 (\$375,725.00) Dollars is hereby appropriated out of the General  
14 Fund of the state of Louisiana for Fiscal Year 2012-2013 to be used to pay the consent  
15 judgment in the suit entitled "James Ronald Fowler, Jr. v. State of Louisiana through the  
16 Department of Transportation and Development", bearing Number 65,944-A on the docket  
17 of the Twenty-Sixth Judicial District Court, parish of Webster, state of Louisiana.

18 Section 2. The sum of Three Hundred Seventy-Five Thousand Seven-Hundred  
19 Twenty-Five and No/100 (\$375,725.00) Dollars is hereby appropriated out of the General  
20 Fund of the state of Louisiana for Fiscal Year 2012-2013 to be used to pay the consent

1 judgment in the suit entitled "Crystal Williams v. State of Louisiana through the Department  
2 of Transportation and Development", bearing Number 65,988 on the docket of the Twenty-  
3 Sixth Judicial District Court, parish of Webster, state of Louisiana.

4 Section 3. This Act shall become effective on July 1, 2012; if vetoed by the governor  
5 and subsequently approved by the legislature, this Act shall become effective on July 1,  
6 2012, or on the day following such approval by the legislature, whichever is later.
