BUDGETARY PROCEDURES: Provides for the inclusion of certain items in the Executive Budget and the General Appropriation Bill

2	To amend and reenact R.S. 39:51(C) and to enact R.S. 39:36(A)(6), relative to budgetary
3	procedures; to require certain categories of expenditures be included in the Executive
4	Budget; to require certain information be included in the General Appropriation Bill:
5	and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 39:51(C) is hereby amended and reenacted and R.S. 39:36(A)(6) is
8	hereby enacted to read as follows:
9	§36. Contents and format of executive budget; supporting document
0	A. The executive budget shall present a complete financial and
1	programmatic plan for the ensuing year, and it shall be configured in a format so as
12	to clearly present and highlight the functions and operations of state government and
13	the financial requirements associated with those functions and operations. The
14	executive budget shall be a performance-based budget. It shall include at a minimum
15	the following:

17	(6) For each program, budget unit, and department, recommended
18	expenditures by major object group expenditures, including but not limited to
19	Salaries, Other Compensation, Related Benefits, Operating Expenses, Professional

Schroder HB No. 1067

Abstract: Requires the Executive Budget contain proposed expenditures by major object group expenditure category for each program, budget unit, and department. Requires such proposed expenditures be included in the General Appropriation Bill.

<u>Present law</u> provides that the executive budget shall clearly present and highlight the functions and operations of state government and the financial requirements associated with those functions and operations, and provides for the minimum information included in the executive budget.

<u>Proposed law</u> requires additional information for each program, budget unit, and department in the form of recommended expenditures by major object group expenditures, including but not limited to Salaries, Other Compensation, Related Benefits, Operating Expenses, Professional Services, and Acquisitions and Major Repairs, and Other Charges and the expenditures of the existing operating budget.

<u>Present law</u> provides that the General Appropriation Bill shall reflect a performance-based budget, with specific appropriations for each agency and its programs to include key objectives and key performance indicators therefor. Provides that the General Appropriation Bill may also contain provisions for specific rewards or penalties for certain agencies as provided in R.S. 39:87.4.

<u>Proposed law</u> provides that the General Appropriation Bill shall also include the summary of recommended expenditures for each program, budget unit, and department by major
