ALCOHOLIC BEVERAGES: Provides relative to the sampling of alcoholic beverages

AN ACT

2	To amend and reenact R.S. 26:75(C) and 275(B), relative to permits for engaging in the
3	business of manufacturing, supplying, or dealing in alcoholic beverages; to authorize
4	the sampling of alcoholic beverages under a Special Event permit; to provide for the
5	payment of certain taxes; to require compliance with certain labeling processes; and
6	to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 26:75(C) and 275(B) are hereby amended and reenacted to read as
9	follows:

12	C.(1) Notwithstanding any law to the contrary, beer, wine, or other spirit
13	sampling for the purpose of allowing a consumer to try the taste of a product may be
14	conducted on the premises of a Class A, or Class B, or a Special Event permit holder.
15	(2) The commissioner shall promulgate rules and regulations for the
16	conducting of spirit beverage alcohol sampling, which shall allow manufacturers and
17	wholesalers to provide and display a limited amount of point of sales materials.
18	(3) Excise taxes shall be paid on all products prior to providing sampling to
19	consumers. All sampling products shall comply with the Department of Health and
20	Hospital's labeling approval process.

Badon HB No. 1159

**Abstract:** Authorizes the sampling of alcoholic beverages by Special Event permit holders.

<u>Present law</u> authorizes beer, wine, or other spirit sampling for the purpose of allowing a consumer to taste a product on the premises of a Class A or Class B permit holder.

<u>Proposed law</u> makes a technical change to <u>present law</u> by using the defined term "beverage alcohol" instead of "spirit", and further authorizes Special Event permit holders to provide sampling to consumers.

<u>Proposed law</u> requires all excise taxes to be paid on all products prior to providing sampling to the consumer.

<u>Proposed law</u> requires compliance with the Dept. of Health and Hospital's labeling approval process.

## Summary of Amendments Adopted by House

## House Floor Amendments to the original bill.

- 1. Required all excise taxes to be paid on all products prior to providing sampling to the consumer.
- 2. Required compliance with the Dept. of Health and Hospital's labeling approval process.
