If the department proposes minor permit modifications or revisions not requested by the permit applicant, the department shall 14 15 provide the permit applicant a reasonable opportunity to review the proposed 16 language of the permit modification or revision prior to issuance of the final permit 17 modification or revision or shall reopen the permit in accordance with applicable 18 <u>law.</u> 19 (5) The secretary shall adopt rules, in accordance with the Administrative 20 Procedure Act, R.S. 49:950 et seq., to implement the requirements of this Subsection. 21 Section 2. This Act shall become effective upon signature by the governor or, if not 22 signed by the governor, upon expiration of the time for bills to become law without signature 23 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 24 vetoed by the governor and subsequently approved by the legislature, this Act shall become 25 effective on the day following such approval.

St. Germain HB No. 1163

Abstract: Provides for certain permit applicants to receive summaries of changes, draft permits, and draft language.

<u>Proposed law</u> requires the Dept. of Environmental Quality, upon request, to provide an applicant a summary of draft changes to an existing permit for a renewal, extension, or substantial permit modification of a hazardous waste, solid waste, La. Pollutant Discharge Elimination System (LPDES), or air quality permit.

<u>Proposed law</u> requires the department upon request, to provide an applicant a reasonable opportunity to review a draft hazardous waste, solid waste, La. Pollutant Discharge Elimination System (LPDES), or air quality permit prior to public notice.

<u>Proposed law</u> provides draft permits that change an existing permits shall clearly identify the change to the existing permit.

<u>Proposed law</u> provides that for minor permit modifications that do not require a draft or public notice, the department shall provide the applicant a reasonable opportunity to review the proposed language either upon request by the applicant or when a modification is proposed by the department.

Effective upon signature of governor or lapse of time for gubernatorial action.
