#### 1 AN ACT 2 To amend and reenact R.S. 18:103(B)(1), (2), (3)(b), and (4), and (C)(1), (2), (3)(b), and (4), 3 154(C), 1306(A)(1) and (4) and (B)(1), 1308(A)(2), 1308.2, 1310(A), and 4 1313(F)(1), (2), (5), (6), and (8) and to enact R.S. 18:1316(C) and 1319, relative to 5 procedures for voter registration and voting for persons in the United States Service and persons residing outside the United States; to provide relative to electronic 6 7 transmission of certain registration and election materials; to provide procedures for 8 the execution and counting of transmitted election materials; to provide for use of the 9 Federal Write-In Absentee Ballot; to provide for effectiveness; and to provide for 10 related matters. 11 Be it enacted by the Legislature of Louisiana: 12 Section 1. R.S. 18:103(B)(1), (2), (3)(b), and (4), and (C)(1), (2), (3)(b), and (4), 13 154(C), 1306(A)(1) and (4) and (B)(1), 1308(A)(2), 1308.2, 1310(A), and 1313(F)(1), (2), 14 (5), (6), and (8) are hereby amended and reenacted and R.S. 18:1316(C) is hereby enacted 15 to read as follows: 16 §103. Personal appearance of applicant required; exceptions 17 B. Any citizen of Louisiana who meets the qualifications set forth in 18 19 R.S. 18:101 and who is a legal resident of this state, whether or not he has a place of 20 abode in this state, but who is unable to appear in person to register because he is in 21 the United States Service, as defined in R.S. 18:1302, may register by mail using the 22 state mail voter registration form in accordance with the following provisions:

| 29 | ballots. The size and weight of paper, size and type of print, and other matters           |

1 secretary of state, subject to approval as to content by the attorney general. All 2 ballots and paraphernalia of the same kind shall be identical as to size and weight of 3 paper, size, type, and color of print, and other matters, except for ballots transmitted 4 electronically to members of the United States Service, as defined in R.S. 18:1302, 5 and to persons residing outside the United States. \* \* 6 7 (4) The secretary of state shall prepare a special absentee ballot for 8 candidates and constitutional amendments to be voted on in second party primary or

9 general elections, subject to approval as to content by the attorney general. This 10 special ballot shall only be for use by a qualified voter who is either a member of the 11 United States Service or who resides outside of the United States. Such special 12 ballot shall contain a list of the titles of all offices being contested at the primary or 13 first party primary election and the candidates qualifying for the primary or first 14 party primary election for each office, and shall permit the elector to vote in the 15 second party primary or general election by indicating his order of preference for 16 each candidate for each office. On the special ballot shall also be printed each 17 constitutional amendment to be voted on in the second party primary or general 18 election. To indicate his order of preference for each candidate for each office to be 19 voted on in the election, the voter shall put the number one next to the name of the 20 candidate who is the voter's first choice, the number two for his second choice and 21 so forth so that, in consecutive numerical order, a number indicating the voter's 22 preference is written by the voter next to each candidate's name on the ballot. A 23 space shall be provided for the voter to indicate his preference for or against each 24 constitutional amendment contained on the ballot. The voter shall not be required 25 to indicate his preference for more than one candidate on the ballot if the voter so 26 chooses. The secretary of state shall also prepare instructions for use of the special 27 ballot, including instructions for voting by mail using an electronically transmitted 28 ballot.

1 (c) The For mailed ballots, the envelope mailed to the voter shall contain six 2 envelopes, three of which shall be the ballot envelopes and three of which shall be 3 return envelopes. Each return envelope shall bear the official title and mailing 4 address of the registrar, whether it contains a primary, first party primary, second 5 party primary or general election ballot, and the name, return address, and precinct 6 or district number of the voter. The voter shall return his voted primary or first party 7 primary election ballot and special ballots for the general election or the second party 8 primary and the general election to the registrar in the appropriate envelopes. The 9 registrar of voters shall not mail a regular general election or the second party 10 primary and general election absentee ballot to a member of the United States 11 Service or to persons residing overseas if the registrar has mailed a special ballot, as 12 provided herein, to such voter. The envelopes for the special ballots shall contain 13 language on the outside of the envelope which will that clearly designate designates 14 which envelope is to be used for return of the second primary election ballot and 15 which envelope is to be used for return of the general election ballot.

16 (d)(i) For each electronically transmitted federal general election ballot, the 17 registrar shall transmit the ballot, certificate, and waiver of the right to a secret ballot 18 to the voter. The waiver of the right to a secret ballot shall contain the following 19 statement: "My ballot was transmitted electronically to me and I am voluntarily 20 waiving my right to a secret ballot." The statement shall also contain a space for the 21 voter's handwritten signature, the date, and the voter's social security number. The 22 voter shall return by mail his voted ballot, completed certificate, and signed waiver 23 of the right to a secret ballot. The registrar and his staff shall take the steps 24 necessary to keep each voted ballot that was transmitted electronically as 25 confidential as practicable.

26 (ii) The voter may use the "Security Envelope" and ballot transmittal
 27 envelope from the Federal Write-in Absentee Ballot to mail the electronically
 28 transmitted federal general election ballot or ballots and certificate to the parish

during a period of declared emergency, whether by mail, facsimile, or other means
