12	B.(1) Restitution may be obtained by corrections services from an offender
13	for expenses incurred by the department or any other law enforcement agency in any
14	escape or attempt to escape from the <del>custody of any facility of the department</del> <u>legal</u>

16	Corrections, or from any place the offender is legally confined.

**Abstract:** Provides for restitution for expenses incurred for an escape or attempted escape from any facility an offender is legally assigned.

<u>Present law</u> provides that restitution may be obtained by corrections services from an offender for expenses incurred by DPS&C or any other law enforcement agency in any escape or attempt to escape from the custody of any facility of the department.

<u>Proposed law</u> amends <u>present law</u> to provide that restitution may be obtained for an escape or attempted escape from any place where the offender is legally confined.

<u>Present law</u> provides that the amount of restitution shall be the actual costs incurred, including but not limited to property damage, staff transportation and lodging, salaries for the duration of the chase, and costs of return of the offender.

<u>Proposed law</u> retains <u>present law</u>. Further provides that <u>proposed law</u> is applicable to all penal, correctional, community rehabilitation centers, transitional work programs, hospitals, clinics, and any and all programs where offenders are legally assigned.
