## TRANSPORTATION DEPT: Authorizes the use of a portion of Interstate 49 as an alternate route for U.S. Highway No. 71 and U.S. Highway No. 167 to haul agronomic or horticultural crop on the interstate system

2	To enact R.S. 32:387.19, relative to special permits; to authorize the use of a portion of
3	Interstate 49 as an alternate route for U.S. Highway No. 71 and U.S. Highway No.
4	167 to haul agronomic or horticultural crops on the interstate; and to provide for
5	related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S.32:387.19 is hereby enacted to read as follows:
8	§387.19. Special permits; authorization to travel on portions of Interstate 49; to
9	hauling of agronomic or horticultural crops
10	Notwithstanding any other provision of the law to the contrary, and provided
11	the federal government does not raise any objection to such permitted weight
12	limitations, the segment of interstate between the interchange of Interstate 49 with
13	U.S. Highway No. 71 and U.S. Highway No. 167 (MacArthur Drive) south of
14	Alexandria and the interchange of Interstate 49 with Rapides Station Road north of
15	Alexandria is hereby deemed as an alternate route for U.S. Highway No. 71 and U.S.
16	Highway No. 167. Any vehicle traveling under a special permit issued under the
17	provisions of this Subpart, the conditions of which permit travel on U.S. Highway
18	No. 71 and U.S. Highway No.167, is hereby authorized to travel Interstate 49 under
19	the same conditions and restrictions as those applicable to its permit to travel on

HB No. 1277

Abstract: Authorizes the use of a portion of Interstate 49 as an alternate route for U.S. Highway No. 71 and U.S. Highway No. 167 to haul agronomic or horticultural crop on the interstate system.

<u>Proposed law</u> authorizes vehicles which are traveling under any special permit issued under <u>present law</u> (R.S. 32-379, et seq. - Size, Weight, and Load of Vehicles) to travel on I-49 as an alternative route for U.S. Highway No. 71 and U.S. No. 167 (MacArthur Drive) south of Alexandria and the interchange of I-49 with Rapides Station Road north of Alexandria.

Provides that the provisions of <u>proposed law</u> shall become null and void and have no effect if federal highway funding is withheld due to the passage of <u>proposed law</u>.
