STATE AGENCIES: Allows state agencies the option of utilizing DOTD to construct, improve, and repair roads surrounding their offices and other facilities when the agency pays for the work to be performed

2	To enact R.S. 48:21(C), relative to functions of the Department of Transportation and
3	Development; to authorize the Department of Transportation and Development to
4	allow state agencies the option to utilize the department to construct, maintain,
5	improve, and repair roads surrounding state offices and other facilities when the
6	agency provides monies for such work to be performed; to provide for certain
7	conditions; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 48:21(C) is hereby enacted to read as follows:
10	§21. Functions
11	* * *
12	C. The department may construct, maintain, and improve roads, whether
13	hard-surfaced or otherwise, for state offices and other surrounding facilities of these
14	agencies. Such work shall be at the direction of, and in cooperation with, the
15	Department of Transportation and Development and shall be funded from monies
16	specifically designated for that purpose. Provided, however, when work is requested
17	to be performed by any state agencies by the Department of Transportation and
18	Development the following conditions shall apply:

1	(1) Any state agency shall provide monies for the construction, maintenance,
2	improvement, and repairing of roads surrounding state offices and other facilities
3	when such work is performed.

5	Development does not interfere with any construction work performed for Highway
6	Priority Program projects.

HB No. 1317

Abstract: Authorizes DOTD to construct, maintain, and improve roads for state agencies and their surrounding facilities when monies are provided by state agencies for certain work to be performed. Provides for exceptions.

<u>Proposed law</u> authorizes DOTD to construct, maintain, and improve roads, whether hardsurfaced or otherwise, for state offices and other surrounding facilities of these agencies. Such work shall be at the direction of, and in cooperation with, DOTD and shall be funded from monies specifically designated for that purpose.

<u>Proposed law</u> provides that when work is requested to be performed by any state agencies by DOTD the following conditions shall apply:

- (1) Requires state agencies to provide monies for the construction, maintenance improvement, and repairing of roads surrounding state offices and other facilities when such work is performed.
- (2) That any work performed by DOTD does not interfere with any construction work performed for Highway Priority Program projects.
