| 8 | Be it enacted by the Legislature of Louisiana: |
| 9 | Section 1. The sum of Three Hundred Thirty-Eight Thousand Four Hundred |
| 10 | Seventy-Three and No/100 (\$338,473.00) Dollars in favor of plaintiff Angela Cotton; the |
| 11 | sum of Three Thousand Two Hundred Four and 93/100 (\$3,204.93) Dollars, in favor of |
| 12 | plaintiff Blaine Cotton; and the sum of Twenty Thousand and No/100 ($$20,000.00$) Dollars, |
| 13 | in favor of plaintiff Andy Cotton; plus court costs, including expert fees, travel expenses, |
| 14 | medical records, and costs of appeal, in the amount of Twenty-Three Thousand Eight |
| 15 | Hundred Fifty-Two and 61/100 (\$23,852.61) Dollars; plus legal interest from April 5, 2007, |
| 16 | until paid, is hereby appropriated out of the General Fund of the state of Louisiana for Fiscal |
| 17 | Year 2012-2013 to be used to pay the judgment in the suit entitled "Angela Cotton, Andy |
| 18 | Cotton and Blaine Cotton v. State Farm Mutual Automobile Insurance Company, Kerry |
| 19 | Carter, Government Employee's Insurance Company, and State of Louisiana, through the |
| 20 | Department of Transportation and Development", bearing Number 151003 "C" on the docket |

- 1 of the Thirty-Second Judicial District Court, parish of Terrebonne, state of Louisiana, and
- 2 bearing Number 2010-CA-1609, on the docket of the First Circuit Court of Appeal, state of
- 3 Louisiana.
- 4 Section 2. The judgment provided for in Section 1 hereof shall be deemed to have
- 5 been paid on the effective date of this Act and legal interest shall cease to run as of that date.
- 6 Section 3. This Act shall become effective on July 1, 2012; if vetoed by the governor

7 and subsequently approved by the legislature, this Act shall become effective on July 1,

8 2012, or on the day following such approval by the legislature, whichever is later.
