2 To enact R.S. 13:101.2 and 101.3 and to repeal R.S. 13:101, 101.1, and 312.4, relative to the 3 supreme court; to provide relative to redistricting supreme court justice districts; to 4 provide for the filling of vacancies; to eliminate statutory provisions for a temporary 5 additional judgeship for the Court of Appeal for the Fourth Circuit and such judge's 6 appointment to the supreme court; and to provide for related matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1. 17	website on the effective date of this Section. The 2024 Precinct Shapefiles are based upon
18	those Voting Districts (VTDs) contained in the 2020 Census Redistricting TIGER/Line
19	Shapefiles for the State of Louisiana as those files have been modified and validated through
20	the data verification program of the Louisiana House of Representatives and the Louisiana
21	Senate to represent precinct changes submitted through January 10, 2024, to the Legislature
22	of Louisiana by parish governing authorities pursuant to the provisions of R.S. 18:532 and
23	532.1.
24	(B) When a precinct referenced in this Act has been subdivided by action of the
25	parish governing authority on a nongeographic basis or subdivided by action of the parish
26	governing authority on a geographic basis in accordance with the provisions of R.S.
27	18:532.1, the enumeration in this Act of the general precinct designation shall include all
28	nongeographic and all geographic subdivisions thereof, however such subdivisions may be
29	designated.

1 (C) The territorial limits of the districts as provided in this Act shall continue in

2 effect until changed by law regardless of any subsequent change made to the precincts by

3 the parish governing authority.

4 Section 4. This Act shall become effective upon signature of the governor or, if not

signed by the governor, upon expiration of the time for bills to become law without signature

by the governor, as provided in Article III, Section 18 of the Constitution of Louisiana. If

this Act is vetoed by the governor and subsequently approved by the legislature, the

8 provisions of this Section and Section 3 of this Act shall become effective on the day

9 following such approval.

Abstract: Provides for the redistricting of the state's supreme court and provides for the composition of seven supreme court districts. Effective upon signature of governor for all purposes.

Statistical summaries of <u>proposed law</u> including maps illustrating proposed district boundaries accompany this digest. (Attached to the bill version on the internet.)

<u>Present constitution</u> (Const. Art. V, §3) provides the supreme court must be composed of a chief justice and six associate justices.

<u>Present constitution</u> (Const. Art. V, §4) provides the state must be divided into at least six supreme court districts, and at least one judge shall be elected from each. Further provides the districts and the number of judges assigned to each on the effective date of the constitution are retained, subject to change by law enacted by two-thirds of the elected members of each house of the legislature.

<u>Proposed law</u> redraws district boundaries for the seven supreme court districts and assigns each justice in office to a district.

<u>Proposed law</u> specifies that precincts referenced in district descriptions are those precincts contained in the file named "2024 Precinct Shapefiles (01-10-2024)" available on the legislature's website. The 2023 Precinct Shapefiles are based upon those Voting Districts (VTDs) contained in the 2020 Census Redistricting TIGER/Line Shapefiles for the State of La. as those files have been modified and validated through the data verification program of the La. House of Representatives and the La. Senate to represent precinct changes submitted through Jan. 10, 2024, to the Legislature of La. by parish governing authorities.

Also specifies that if any such precinct has been subdivided by action of the parish governing authority on a nongeographic basis or subdivided by action of the parish governing authority on a geographic basis in accordance with <u>present law</u>, the enumeration of the general precinct designation shall include all nongeographic and all geographic

subdivisions thereof. Further provides that the territorial limits of the districts as enacted shall continue in effect until changed by law regardless of any subsequent change made to the precincts by the parish governing authority.

Population data in the summaries accompanying this digest are derived from 2020 Census Redistricting Data (Public Law 94-171), Summary File for La. Population data, statistical information, and maps are supplied for purposes of information and analysis and comprise no part of proposed law.

<u>Proposed law</u> provides that the new districts become effective upon signature of governor or lapse of time for gubernatorial action.
