- 1. Reduce the appropriation to the Secretary of State for the Elections Program for the purpose of calling and holding a special election on constitutional amendments from \$8,000,000 to \$5,200,000.
- 2. Appropriate \$1,400,000 to the Secretary of State for the Elections Program for expenses related to Congressional redistricting mailings.
- 3. Appropriate \$1,400,000 to the Secretary of State for the Elections Program for expenses related to Louisiana Supreme Court redistricting mailings.
