CENSUS: Provides relative to provisions in Title 34 which are limited in applicability to political subdivisions or local areas meeting specified population characteristics (Item #8)

AN ACT

2	To amend and reenact R.S. 34:851.27(B)(8), 3521(A), and 3522(A), relative to provisions			
3	of Title 34 (Navigation and Shipping) of the Louisiana Revised Statutes of 1950			
4	which are limited in applicability to certain political subdivisions or local areas based			
5	upon population classifications; to specify applicability to one or more political			
6	subdivisions or local areas; and to provide for related matters.			
7	Be it enacted by the Legislature of Louisiana:			
8	Section 1. R.S. 34:851.27(B)(8), 3521(A), and 3522(A) are hereby amended and			
9	reenacted to read as follows:			
10	§851.27. Local regulations prohibited; exceptions; speed limits

14	(8) Notwithstanding any law to the contrary, the local governing authority			
15	of any parish with a population in excess of four hundred forty thousand according			
16	to the latest federal census the parishes of Orleans and Jefferson may regulate or			
17	prohibit watercraft operating within two hundred fifty feet of any structures on any			
18	water bottoms in Lake Pontchartrain leased by said local governing authority from			
19	the state for recreational purposes.

A. In addition to any other authority or power granted by law, the board of commissioners for a port authority in whose boundaries are coterminous with parishes having a population between thirty-nine thousand and forty thousand, according to the latest federal decennial census, Natchitoches Parish shall have authority to make and enter into contracts, leases, and other agreements with railroads, trucking companies, bargelines, and with any and all companies interested in the transportation, storage, and shipping of goods and other products, whether by rail, truckline, bargeline, or otherwise, for the use of facilities administered by the commission or any part or portion thereof for a period of time not exceeding ninety-nine years. However, no exclusive franchise shall be granted to any carrier.

§3522. Authorities in certain parishes

A. Notwithstanding any provision of law to the contrary, there is hereby created in any parish having a population of not more than one hundred thirty thousand and not less than one hundred twenty-five thousand as determined by the most recent federal decennial census, Rapides Parish a port authority in such parish and adjacent lands, except as provided in Subsection B of this Section.

**Abstract:** Updates applicability of provisions in Title 34 as a result of the 2010 census.

<u>Proposed law</u>, contained in Title 34 (Navigation and Shipping) of the Louisiana Revised Statutes of 1950, legislates with regard to classifications of parishes, municipalities, or other political subdivisions or local areas according to population by amending local bills to limit the application of laws based upon specific classifications to one or more parishes, municipalities, or other political subdivisions or local areas, as follows:
