SECRETARY OF STATE: Provides relative to fees charged by the secretary of state

1 AN ACT

2 To amend and reenact R.S. 49:222(A) and to enact R.S. 49:222(B)(15) and (16), relative to
3 fees charged by the secretary of state; to provide for technical changes; to provide
4 for motor vehicle contract provider application fees; to provide for motor vehicle
5 contract provider renewal fees; to provide for structured settlement registration fees;
6 to provide for structured settlement renewal fees; and to provide for related matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. R.S. 49:222(A) is hereby amended and reenacted and R.S. 49:222(B)(15)
9 and (16) are hereby enacted to read as follows:

10 §222. Fees chargeable by secretary of state

11 A. The secretary of state shall determine and collect, in accordance with the
12 Administrative Procedure Act, ~~such~~ fees, other than the fees provided in Subsection
13 B of this Section and other than fees for elections, as are reasonably necessary to
14 carry out the duties of the office. The secretary of state shall publish a listing of ~~such~~
15 fees annually in the official journal of the state.

16 B. The secretary of state is authorized to collect the following fees:

17 * * *

18 (15) Motor vehicle contract provider applications.

19 (a) Six hundred dollars for filing applications for motor vehicle contract
20 providers.

- 1 (b) Two hundred fifty dollars for filing renewals for motor vehicle contract
2 providers.
- 3 (16) Structured settlements.
- 4 (a) Six hundred dollars for filing initial structured settlement registrations.
- 5 (b) Two hundred fifty dollars for filing renewals for structured settlement
6 registrations.

Abstract: Authorizes the secretary of state to collect fees related to motor vehicle contract provider applications and structured settlements.

Present law requires the secretary of state to determine and collect, in accordance with the Administrative Procedure Act, fees that are reasonably necessary to carry out the duties of the office.

Proposed law retains present law.

Present law excludes fees provided for in present law and fees for elections.

Proposed law retains present law.

Present law requires the secretary of state to publish a listing of fees annually in the official journal of the state.

Proposed law retains present law.

Proposed law makes technical changes.

Proposed law authorizes the secretary of state to collect a fee of \$600 for filing applications for motor vehicle contract providers.

Proposed law authorizes the secretary of state to collect a fee of \$250 for filing renewals for motor vehicle contract providers.

Proposed law authorizes the secretary of state to collect a fee of \$600 for filing initial structured settlement registrations.

Proposed law authorizes the secretary of state to collect a fee of \$250 for filing renewals for structured settlement registrations.
