AN ACT

CRIME: Provides relative to drug-related overdoses

2	To amend and reenact R.S. 14:403.10(B), relative to drug-related overdoses; to provide
3	relative to immunity from prosecution for drug-related overdoses; to provide that
4	immunity from prosecution, charges, or penalties for drug-related overdoses does not
5	apply under certain circumstances; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 14:403.10(B) is hereby amended and reenacted to read as follows:
8	§403.10. Drug-related overdoses; medical assistance; immunity from prosecution
9	* * *
10	B.(1) A Except as provided in Paragraph (2) of this Subsection, a person who
11	experiences a drug-related overdose and is in need of medical assistance shall not be
12	charged, prosecuted, or penalized for possession of a controlled dangerous substance
13	under the Uniform Controlled Dangerous Substances Law if the evidence for
14	possession of a controlled substance was obtained as a result of the overdose and the
15	need for medical assistance.
16	(2) The provisions of this Subsection shall not apply when first responders
17	or law enforcement officers respond to the same residence two or more times for a
18	person experiencing a drug-related overdose.

Abstract: Provides that immunity from prosecution, charges, or penalties for possession of a controlled dangerous substance for persons experiencing drug-related overdoses does not apply when first responders or law enforcement officers respond to the same residence two or more times.

<u>Present law</u> provides that a person who experiences a drug-related overdose and is in need of medical assistance shall not be charged, prosecuted, or penalized for possession of a controlled dangerous substance under the Uniform Controlled Dangerous Substances Law if the evidence for the possession of the controlled dangerous substance was obtained as a result of the overdose and the person's need for medical assistance.

<u>Proposed law</u> amends <u>present law</u> to provide that the immunity from prosecution, charges, or penalties does not apply when first responders or law enforcement officers respond to the same residence two or more times for a person experiencing a drug-related overdose.
