AN ACT

HIGHWAYS: Designates a highway

2 To designate Louisiana Highway 34 from Louisiana Highway 546 to Kings Lake Road as 3 the "Corporal J.R. Searcy Memorial Highway"; and to provide for related matters. 4 Be it enacted by the Legislature of Louisiana: 5 Section 1. Louisiana Highway 34 from Louisiana Highway 546 to Kings Lake Road 6 shall be hereinafter known and designated as the "Corporal J.R. Searcy Memorial Highway." 7 The Department of Transportation and Development shall erect appropriate signage 8 reflecting this designation. Corporal Searcy spent the majority of his adult life serving the 9 citizens of Ouachita Parish as a proud member of the Ouachita Parish Sheriff's Office. 10 Corporal Searcy honorably served as a patrol deputy, a K-9 deputy, and a training officer for 11 the patrol division. On March 6, 2010, Corporal Searcy died as a result of a gun-shot wound 12 received while responding to an aggravated assault complaint and backing up a fellow 13 deputy sheriff. Corporal Searcy was thirty-three years old when he died in the line of duty, 14 bravely serving and protecting the citizens of Ouachita Parish and enforcing the laws he was 15 sworn to enforce. Corporal Searcy is survived by his wife and three children. Even in death, 16 Corporal Searcy continued to serve his community as his organs were donated to save 17 citizens in need of organ transplants. The family, friends, and fellow deputies were all proud 18 of Corporal Searcy and will deeply miss his friendship and service. 19 Section 2. The section of United States Highway from the intersection of Louisiana 20 Highway 38 to the Mississippi state line shall hereinafter be known and designated as the 21 "Trooper Rudolph H. Miller Memorial Highway."

- 1 Section 3. The section of Louisiana Highway 118 from Florien to Kisatchie shall
- 2 hereinafter be known and designated as the "Louisiana Maneuvers and Purple Heart
- 3 Memorial Highway."
- 4 Section 4. The section of Louisiana Highway 749 from the intersection of West
- 5 Martin Luther King Drive to the intersection of Louisiana Highway 167 shall hereinafter be
- 6 known and designated as the "Griffin Pat Miller Memorial Highway."
- 7 Section 5. This Act shall become effective upon signature by the governor or, if not
- 8 signed by the governor, upon expiration of the time for bills to become law without signature
- 9 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 11 effective on the day following such approval.
