2	To enact R.S. 49:191(5)(b) and to repeal R.S. 49:191(3)(p), relative to the Department of
3	Veterans Affairs, including provisions to provide for the re-creation of the
4	Department of Veterans Affairs and the statutory entities made a part of the
5	department by law; to provide for the effective termination date for all statutory
6	authority for the existence of such statutory entities; and to provide for related
7	matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. Pursuant to R.S. 49:193, the Department of Veterans Affairs and the
10	statutory entities made a part of the department by law shall be re-created effective June 30,
11	2010, and all statutory authority therefor is continued in accordance with the provisions of
12	Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.
13	Section 2. All statutory authority for the existence of the Department of Veterans
14	Affairs and the statutory entities made a part of the department as re-created by Section 1
15	of this Act shall cease as of July 1, 2015, pursuant to R.S. 49:191. However, the Department
16	of Veterans Affairs may be re-created prior to such date in accordance with the provisions
17	of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.
18	Section 3. The provisions of R.S. 49:193 are hereby superseded to the extent that
19	those provisions are in conflict with the provisions of this Act.
20	Section 4. R.S. 49:191(5)(b) is hereby enacted to read as follows:
21	§191. Termination of legislative authority for existence of statutory entities; phase-
22	out period for statutory entities; table of dates
23	Notwithstanding any termination dates set by any previous Act of the
24	legislature, the statutory entities set forth in this Section shall begin to terminate their
