APPROPRIATIONS/SUPPLEML: To make supplemental appropriations for the 2023-2024 Fiscal Year (Item # 6)

1	AN ACT
2	To appropriate funds and to make certain reductions from certain sources to be allocated to
3	the designated agencies and purposes in specific amounts for the making of
4	supplemental appropriations and reductions for said agencies and purposes for Fiscal
5	Year 2023-2024; to provide legislative findings; to provide for an effective date; and
6	to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. The legislature finds that food insecurity has been scientifically linked to
9	negative impacts on the health and psychological well-being of those who suffer from it.
10	It has also been linked in multiple scientific articles to interpersonal and self-directed
11	violence. The legislature therefore finds that addressing food insecurity is a viable strategy
12	for combating multiple forms of violence and that any funding that ameliorates the problem
13	of food insecurity in our state can only have a positive impact on the administration of
14	criminal justice and juvenile justice in our state.
15	Section 2. The following sums are hereby appropriated from the sources specified for
16	the purpose of making supplemental appropriations for Fiscal Year 2023-2024. Reductions
17	are denoted in parentheses.

- signed by the governor, upon expiration of the time for bills to become law without signature
- by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 16 effective on the day following such approval.
