CIVIL/IMMUNITY: Provides for immunity from civil liability under certain circumstances for peace officers and public entities that employ or appoint peace officers (Item #13)

AN ACT

2	To enact R.S. 9:2793.11, relative to immunity from liability for peace officers and certain
3	public entities; to provide for immunity from civil liability for peace officers and
4	certain public entities; to provide for definitions; to provide for exceptions; and to
5	provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 9:2793.11 is hereby enacted to read as follows:
8	§2793.11. Limitation of liability for peace officers performing their duties;
9	definitions; exceptions
10	A. As used in this Section:
11	(1) "Discretionary function" means any action or conduct of a peace officer,
12	acting within the course and scope of his law enforcement duties, that includes
13	exercising judgment in the enforcement of the criminal laws of the state including
14	but not limited to arresting or attempting to arrest persons or carrying out any other
15	duties or obligations imposed upon a peace officer in this state.
16	(2) "Peace officer" shall include all individuals as defined in R.S. 40:2402(3)
17	and R.S. 14:112.4(B)(2).
18	(3) "Public entity" means the state or a political subdivision of the state that
19	employs or appoints any peace officer as defined in Paragraph (2) of this Subsection.

Abstract: Prohibits civil claims against peace officers and certain public entities based upon the conduct or actions of a peace officer in performance of any discretionary function within the course and scope of his law enforcement duties.

<u>Proposed law</u> provides definitions for "discretionary function", "peace officer", and "public entity".

<u>Proposed law</u> prohibits civil claims for damages against a peace officer or public entity that employs or appoints a peace officer under any of the following circumstances:

- (1) The conduct or actions of the peace officer arise out of the performance of any discretionary function within the course and scope of the peace officer's law enforcement duties.
- (2) The success of the claim necessarily implies the invalidity of a criminal conviction or sentence, unless the conviction or sentence has been invalidated through appropriate legal proceedings.

<u>Proposed law</u> provides that <u>proposed law</u> shall not apply to any of the following:
