1	AN ACT
2	To amend and reenact R.S. 32:1(1.1) and 190(D) and to enact R.S. 32:401(24) and
3	408(C)(3), relative to autocycles; to amend the definition of autocycle; to provide for
4	a helmet exemption for operators and passengers of certain autocycles; to provide
5	for an exemption for certain driver's license endorsements for operators of certain
6	autocycles; to provide for an effective date; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 32:1(1.1) and 190(D) are hereby amended and reenacted and R.S.
9	32:401(24) and 408(C)(3) are hereby enacted to read as follows:
10	§1. Definitions
11	When used in this Chapter, the following words and phrases have the
12	meanings ascribed to them in this Section, unless the context clearly indicates a
13	different meaning:

15	(1.1)(a) "Autocycle" means an enclosed motorcycle that is equipped with
16	safety belts, rollbar or roll cage, windshield wipers, steering wheel, and equipment
17	otherwise required on a motorcycle and which that has no more than three wheels in
18	contact with the roadway at any one time.
19	(b) For purposes of this Paragraph, "roll cage" shall mean a hardtop
20	enclosure protecting occupants from the elements that will support the vehicle's

4	\$190. Safety helmets

6	D. This Section does not apply to a person operating or riding in an
7	autocycle if the vehicle is equipped with a roof which that meets or exceeds
8	standards for a safety helmet or a roll cage. As used in this Subsection, "roll cage"
9	shall mean a hardtop enclosure protecting occupants from the elements that will
10	support the vehicle's weight and is so designed as to protect the occupants when the
11	vehicle is resting on this enclosure.

13	§401. Definitions
14	The following words and phrases when used in this Chapter shall have the
15	meaning herein assigned unless the context clearly indicates otherwise.

17	(24)(a) "Autocycle" means a three-wheeled motorcycle on which the driver
18	and all passengers ride in a completely enclosed seating area that is equipped with
19	a roll cage, safety belts for all occupants, airbag protection, antilock brakes, and is
20	designed to be controlled with a steering wheel and pedals.
21	(b) For purposes of this Paragraph, "roll cage" shall mean a hardtop
22	enclosure protecting occupants from the elements that will support the vehicle's
23	weight and is so designed as to protect the occupants when the vehicle is resting on
24	this enclosure.
