ELECTIONS/POLLING PLACES: Provides for permissible acts within the campaign-free zone at polling places

AN ACT

2 To amend and reenact R.S. 18:1462(A)(2) and (C), relative to activities conducted within 3 the campaign-free zone during early voting or on election day; to authorize activities 4 not otherwise prohibited by law within the campaign-free zone; to provide for 5 effectiveness; and to provide for related matters. 6 Be it enacted by the Legislature of Louisiana: 7 Section 1. R.S. 18:1462(A)(2) and (C) are hereby amended and reenacted to read as 8 follows: 9 §1462. Acts prohibited during early voting or on election day; electioneering; 10 intimidation; exceptions; enforcement; penalties 11 A. The Legislature of Louisiana recognizes that the right to vote is a right 12 that is essential to the effective operation of a democratic government. In order to 13 preserve the integrity of its election process, and to protect the right of citizens to 14 vote freely for the candidates of their choice, the state has a compelling interest in 15 establishing a zone securing polling locations against certain conduct and activities, 16 including voter intimidation, election fraud, confusion, and general disorder, that 17 would interfere with the exercise of the right to vote. The legislature, therefore, 18 enacts this Subsection to provide for a six hundred foot campaign-free zone around 19 polling places to provide to each voter such an environment in which to exercise his right to vote. Except as otherwise specifically provided by law, it shall be unlawful 20

Abstract: Authorizes otherwise lawful activities within the 600-foot campaign-free zone around polling places.

<u>Present law</u> prohibits various campaigning activities in a polling place or within 600 feet of a polling place on election day or during early voting.

<u>Present law</u> provides that it is unlawful for any person to remain within any polling place or within a radius of 600 feet of the entrance of any polling place after having been directed by an election commissioner, law enforcement officer, registrar, or deputy registrar to leave the premises or area of a polling place, except when exercising the right to vote.

<u>Proposed law</u> retains <u>present law</u> and further provides an exception for any person engaging in other lawful activities.

<u>Proposed law</u> provides that no person or entity shall be prohibited from engaging in activities within the campaign-free zone that are not otherwise prohibited by law.

Effective upon signature of the governor or lapse of time for gubernatorial action.
