2	To amend and reenact R.S. 33:423.21, relative to Title 33 (Municipalities and Parishes) of		
3	the Louisiana Revised Statutes of 1950 which are limited in applicability to certain		
4	political subdivisions or local areas based upon population category; to specify		
5	applicability to Independence of a provision relative to the authority of the police		
6	chief to take certain personnel actions; and to provide for related matters.		
7	Be it enacted by the Legislature of Louisiana:		
8	Section 1. R.S. 33:423.21 is hereby amended and reenacted to read as follows:		
9	§423.21. Certain municipalities <u>Town of Independence</u> ; authority over personnel by		
10	elected chief of police		
11	Notwithstanding the provisions of R.S. 33:423 or any other provision of law		
12	to the contrary, in and for any municipality having a population of not more than one		
13	thousand eight hundred persons and not less than one thousand six hundred fifty		
14	persons according to the latest federal decennial census and located in any parish		
15	with a population of not more than one hundred four thousand persons and not less		
16	than ninety-eight thousand five hundred persons according to the latest federal		
17	decennial census the town of Independence, the chief of police shall appoint,		
18	promote, discipline, and discharge police personnel subject to the budgetary		
19	limitations of the mayor and town council pertaining to the number of allotted		
20	positions for the police department.

Abstract: Relative to the authority of an elected police chief to take certain personnel actions, specifies applicability of provisions (as a result of the 2010 census) which are limited in applicability (by population) to the town of Independence.

<u>Present law</u> provides generally for the powers and duties of an elected police chief. Requires the police chief to make recommendations to the mayor and board of aldermen for the appointment of police personnel, the promotion of officers, to effect disciplinary action, and for dismissal of police personnel. Provides exceptions.

Proposed law retains present law.

<u>Present law</u> requires the police chief in any municipality having a population of not more 1,800 persons and not less than 1,650 persons according to the latest federal decennial census and located in any parish with a population of not more than 104,000 persons and not less than 98,500 persons according to the latest federal decennial census to appoint, promote, discipline, and discharge police personnel subject to the budgetary limitations of the mayor and town council pertaining to the number of allotted positions for the police department.

<u>Proposed law</u> makes <u>present law</u> applicable to the town of Independence.
