1 AN ACT 2 To amend and reenact R.S. 3:264(B)(2) and to repeal R.S. 3:264(B)(5), relative to the 3 Louisiana Agricultural Finance Authority; to provide for membership of the 4 authority; to require certain appointments by the governor; to remove a member 5 appointed from a list provided by the Community Bankers of Louisiana; to provide 6 for an effective date; and to provide for related matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1. R.S. 3:264(B)(2) is hereby amended and reenacted to read as follows: 9 §264. Louisiana Agricultural Finance Authority 10 11 B. The authority shall be composed of nine members. The commissioner of 12 agriculture and forestry shall serve ex officio with the same rights and privileges, 13 including voting rights, as other members. The chair of the Senate Committee on 14 Agriculture, Forestry, Aquaculture and Rural Development or his designee, the chair 15 of the House Committee on Agriculture, Forestry, Aquaculture and Rural 16 Development or his designee, and the secretary of the Department of Economic 17 Development or his designee, shall serve in an advisory capacity, without voting

This Act shall become effective upon signature by the governor or, if not 6 signed by the governor, upon expiration of the time for bills to become law without signature 7 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 8 vetoed by the governor and subsequently approved by the legislature, this Act shall become 9 effective on the day following such approval.

Abstract: Increases the number of members of the La. Agricultural Finance Authority appointed by the governor from a list of six persons nominated by the La. Bankers Association.

<u>Present law</u> requires an appointment, by the governor, of one member to the La. Agricultural Finance Authority from a list of six persons nominated by the La. Bankers Association. <u>Proposed law</u> retains <u>present law</u> but changes the number of members appointed <u>from</u> one member <u>to</u> two members.

<u>Present law</u> requires an appointment, by the governor, of one member to the authority from a list of six persons nominated by the Community Bankers of La. <u>Proposed law</u> repeals <u>present law</u>.

Effective upon signature of governor or lapse of time for gubernatorial action.
