AN ACT

2	To enact R.S. 32:411.2 and R.S. 40:1321(N)(3) and (4), relative to the issuance, renewal, or
3	revocation of a driver's license or special identification card; to prohibit the use of
4	vaccination verification or immunity status for the issuance, renewal, or revocation
5	of a state-issued driver's license or special identification card; to prohibit the
6	inclusion of vaccination verification or immunity status on a state-issued driver's
7	license or special identification card; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 32:411.2 is hereby enacted to read as follows:
10	§411.2. Prohibition against the inclusion of vaccination verification or immunity
11	status on driver's licenses
12	A. The Department of Public Safety and Corrections, office of motor
13	vehicles, is prohibited from making the issuance, renewal, or revocation of a state-
14	issued driver's license contingent on vaccination verification or immunity status.
15	B. The Department of Public Safety and Corrections, office of motor
16	vehicles, shall not include any vaccination verification or immunity status on a state-
17	issued driver's license.

19	Section 2. R.S. 40:1321(N)(3) and (4) are hereby enacted to read as follows:
20	§1321. Special identification cards; issuance; veteran designation; disabled veteran
21	designation; university logo; "I'm a Cajun" designation; needs
22	accommodation designation; fees; expiration and renewal; exceptions;
