AN ACT

2	To enact R.S. 47:305.66 and 337.9(D)(31), relative to sales and use tax exemptions; to
3	provide for a state and local sales and use tax exemption for sales of certain property
4	to the "Make It Right Foundation"; to provide for an effective date; and to provide
5	for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 47:305.66 and 337.9(D)(31) are hereby enacted to read as follows:
8	§305.66. Exemption; "Make It Right Foundation"
9	The sales and use tax imposed by the state of Louisiana or any political
10	subdivision shall not apply to the sale of construction materials to the "Make It Right
11	Foundation" when such materials are intended for use in constructing new residential
12	dwellings in this state.

Abstract: Provides for a state and local sales and use tax exemption for sales of construction materials to the "Make It Right Foundation".

<u>Proposed law</u> provides for a state and local sales and use tax exemption for the sale of construction materials to the "Make It Right Foundation" when such materials are intended for use in constructing new residential dwellings in this state.

<u>Present law</u> provides for a listing by key word of mandatory local sales and use tax exemptions.

<u>Proposed law</u> retains <u>present law</u> but adds the exemption in <u>proposed law</u> for the sale of construction materials to the "Make It Right Foundation" to the list of mandatory local sales and use tax exemptions.

Effective July 1, 2011.
