DISTRICTS/NEIGHBORHOOD: Creates the Glen Oaks Crime Prevention District in East Baton Rouge Parish

AN ACT

2 To enact R.S. 33:9097.12, relative to East Baton Rouge Parish; to create the Glen Oaks 3 Crime Prevention District within the parish; to provide relative to the purpose, 4 boundaries, governance, and powers and duties of the district; to provide for the 5 imposition of a parcel fee and for the use thereof; and to provide for related matters. Notice of intention to introduce this Act has been published 6 7 as provided by Article III, Section 13 of the Constitution of 8 Louisiana. 9 Be it enacted by the Legislature of Louisiana: 10 Section 1. R.S. 33:9097.12 is hereby enacted to read as follows: 11 §9097.12. Glen Oaks Crime Prevention District 12 A. Creation. There is hereby created within the parish of East Baton Rouge, 13 as more specifically provided in Subsection B of this Section, a body politic and 14 corporate which shall be known as the Glen Oaks Crime Prevention District, referred 15 to in this Section as the "district". The district shall be a political subdivision of the 16 state as defined in the Constitution of Louisiana. 17 B. Boundaries. The district shall include the area within the following 18 boundaries: beginning at the intersection of Airline Highway and Plank Road, southeast along Airline Highway to its intersection with Hanks Drive, then east along 19 20 Hanks Drive to its intersection with Lanier Drive, then north along Lanier Drive to

| 4 | C. Purpose. The purpose of the district shall be to aid in crime prevention |
| 5 | and to add to the security of district residents by providing for an increase in the |
| 6 | presence of law enforcement personnel in the district. |
| 7 | D. Governance. (1) The district shall be governed by a board of |
| 8 | commissioners, referred to in this Section as the "board", consisting of five members |
| 9 | as follows: |
| 10 | (a) Two members shall be appointed by the state representative for House |
| 11 | District No. 29. |
| 12 | (b) Two members shall be appointed by the state senator for Senate District |
| 13 | <u>No. 15.</u> |
| 14 | (c) One member shall be appointed by the member or members of the |
| 15 | governing authority of the parish of East Baton Rouge who represent the district. |
| 16 | (2) All members of the board shall own immovable property within the |
| 17 | district. |
| 18 | (3) Members of the board shall serve four-year terms after initial terms as |
| 19 | provided in this Paragraph. Two members shall serve an initial term of one year; one |
| 20 | member shall serve two years; one member shall serve three years; and one member |
| 21 | shall serve four years, as determined by lot at the first meeting of the board. |
| 22 | (4) Vacancies resulting from the expiration of a term or any other reason |
| 23 | shall be filled for the remainder of the unexpired term in the manner of the original |
| 24 | appointment. Members shall be eligible for reappointment. |
| 25 | (5) The members of the board shall select from among themselves a |
| 26 | president and such other officers as they deem appropriate. The responsibilities of |
| 27 | the officers shall be as provided by the bylaws of the board. |
| 28 | (6) The members of the board shall serve without compensation and shall not |
| 29 | receive reimbursement for expenses. |

| 1 | E. Powers and duties. The district, acting through its board of |

| 14 | F. Parcel fee. The governing authority of East Baton Rouge Parish may |
| 15 | impose and collect a parcel fee within the district subject to and in accordance with |
| 16 | the provisions of this Subsection: |
| 17 | (1) The amount of the fee shall be as requested by duly adopted resolution |
| 18 | of the board. The fee, however, shall not exceed one hundred dollars per parcel per |
| 19 | year for lots zoned for residential use and five hundred dollars per year for lots zoned |
| 20 | for commercial use. |
| 21 | (2)(a) The fee shall be imposed on each improved parcel located within the |
| 22 | district. |
| 23 | (b) For purposes of this Section, "parcel" means a lot, a subdivided portion |
| 24 | of ground, or an individual tract and does not mean a "condominium parcel" as |
| 25 | defined in R.S. 9:1121.103. Thus, with respect to condominiums, the fee collector |
| 26 | shall impose the parcel fee on each lot on which condominiums are situated and not |
| 27 | on individual condominium units. |
| 28 | (c) The owner of the parcel shall be responsible for payment of the fee. |

1 H. Miscellaneous provisions. (1) It is the purpose and intent of this Section 2 that the additional law enforcement personnel and services provided by the district 3 shall be supplemental to and not in lieu of personnel and services provided in the 4 district by the city of Baton Rouge and parish of East Baton Rouge. (2) If the district ceases to exist, any funds of the district shall be transmitted 5 to the governing authority of the city of Baton Rouge and parish of East Baton 6 7 Rouge and shall be used for law enforcement purposes in the area included within 8 the district. 9 Section 2. This Act shall become effective upon signature by the governor or, if not 10 signed by the governor, upon expiration of the time for bills to become law without signature 11 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 12 vetoed by the governor and subsequently approved by the legislature, this Act shall become 13 effective on the day following such approval.

Barrow HB No. 351

Abstract: Creates the Glen Oaks Crime Prevention District in East Baton Rouge Parish for the purpose of aiding in crime prevention and adding to the security of district residents by providing for an increase in the presence of law enforcement personnel in the district. Creates and provides for the district's board of commissioners. Provides for the imposition and use of a parcel fee.

<u>Proposed law</u> creates the Glen Oaks Crime Prevention District in East Baton Rouge Parish for the purpose of aiding in crime prevention and adding to the security of district residents by providing for an increase in the presence of law enforcement personnel in the district. Provides for district boundaries.

<u>Proposed law</u> provides that the district shall be governed by a five-member board of commissioners. Requires each board member to be a property owner in the district. Provides that the board shall be composed as follows:

- (1) Two members appointed by the state representative for House District No. 29.
- (2) Two members shall be appointed by the state senator for Senate District No. 15.
- One member appointed by the member(s) of the governing authority of the parish of East Baton Rouge who represent the district.

<u>Proposed law</u> provides that members serve four-year staggered terms. Requires board members to serve without compensation and provides that they shall not receive reimbursement for expenses.

<u>Proposed law</u> provides that the district, acting through the board, shall have the following powers and duties:

- (1) To sue and be sued.
- (2) To adopt, use, and alter at will a corporate seal.
- (3) To receive and expend funds collected pursuant to <u>proposed law</u> and in accordance with a budget adopted as provided by proposed law.
- (4) To enter into contracts with individuals or entities, private or public, for the provision of security patrols in the district.
- (5) To purchase items and supplies which the board deems instrumental to achieving the purpose of the district.
- (6) To perform or have performed any other function or activity necessary for the achievement of the purpose of the district.

<u>Proposed law</u> authorizes the governing authority of East Baton Rouge Parish to impose and collect a parcel fee within the district. Provides that the amount of the fee shall be as requested by the board. Further provides that the fee shall be a flat fee per improved parcel not to exceed \$100 per parcel per year for lots zoned for residential use and \$500 per year for lots zoned for commercial use. Requires that the fee be imposed on each improved parcel located within the district.

<u>Proposed law</u> defines a parcel as a lot, a subdivided portion of ground, or an individual tract. Provides that a parcel does not mean a condominium parcel as defined in <u>present law</u> (R.S. 9:1121.103). Provides that with respect to condominiums, the fee collector shall impose the parcel fee on each lot on which condominiums are situated and not on individual condominium units.

<u>Proposed law</u> provides that the fee shall be imposed only after the question of its imposition has been approved by a majority of the registered voters of the district voting on the proposition at an election held for that purpose. Provides that no other election shall be required except as provided by <u>proposed law</u>.

<u>Proposed law</u> requires the board of commissioners, at least 30 days prior to any election held to approve imposition of a parcel fee, to mail notification of the upcoming election to each registered voter of the district, and the owner of a parcel if the owner is not a registered voter of the district.

<u>Proposed law</u> requires the initial election on the question of the imposition to be held at the same time as a regularly scheduled election in East Baton Rouge Parish. Provides that the fee shall expire eight years from its initial levy. Authorizes renewal of such fee.

<u>Proposed law</u> requires that the fee be collected at the same time and in the same manner as ad valorem taxes are collected. Further requires the parish to collect and remit to the district all amounts collected not more than 60 days after collection. Provides that the parish may retain a 1% collection fee.

<u>Proposed law</u> requires the board of commissioners to adopt an annual budget in accordance with the Local Government Budget Act and provides that the district shall be subject to audit by the legislative auditor.

Further provides that if the district ceases to exist, any funds of the district shall be transmitted to the governing authority of the city of Baton Rouge and parish of East Baton Rouge and shall be used for law enforcement purposes in the area included within the district.
