DISTRICTS/HOSPITAL SERVC: Provides relative to the Parish Hospital Service District for the parish of Orleans

1	AN ACT
2	To amend and reenact R.S. 46:1095(B)(1) and to reenact R.S. 46:1095(C), relative to
3	Orleans Parish; to provide relative to the Parish Hospital Service District for the
4	parish of Orleans; to provide relative to the membership of the governing boards of
5	the two areas of the district; to reenact provisions relative to such governing boards;
6	and to provide for related matters.
7	Notice of intention to introduce this Act has been published
8	as provided by Article III, Section 13 of the Constitution of
9	Louisiana.
10	Be it enacted by the Legislature of Louisiana:
11	Section 1. R.S. 46:1095(B)(1) is hereby amended and reenacted and R.S. 46:1095(C)
12	is hereby reenacted to read as follows:
13	§1095. Board of commissioners; membership; appointment; terms; compensation;
14	removal
15	* * *
16	B. Each commission shall be composed as follows:
17	(1) Seven members shall be appointed by the chief executive officer of the
18	parish-, one of whom shall be appointed from each list of nominations submitted as
19	<u>follows:</u>

1	(a) Three nominees shall be submitted by the member of the governing
2	authority of the city of New Orleans whose district encompasses all or the greater
3	portion of the area in which the district is located.
4	(b) Three nominees shall be submitted by the member of the Louisiana
5	House of Representatives whose district encompasses all or the greater portion of the
6	area in which the district is located.
7	(c) Three nominees shall be submitted by the member of the Louisiana
8	Senate whose district encompasses all or the greater portion of the area in which the
9	district is located.
10	(d) Each commissioner shall demonstrate expertise in one or more of the
11	following areas: medical litigation, fundraising and philanthropy, accounting,
12	business development, indigent care, community relations, government relations,
13	women's health, minority health, geriatric medicine, nursing, any other medical field,
14	or consumer advocacy.
15	* * *
16	C.(1) The members serving pursuant to Paragraphs $(B)(1)$ and (2) of this
17	Section shall serve at the pleasure of the chief executive officer of the parish.
18	(2) The members serving pursuant to Paragraphs (B)(3) through (7) of this
19	Section shall serve during their terms of office.
20	(3) Any vacancy in the membership of the commission occurring by reason
21	of the expiration of term of office, death, resignation, disqualification, or otherwise
22	shall be filled in the same manner as the original appointment within thirty days of
23	such vacancy. If the appointing authority fails to fill the vacancy within thirty days
24	of such vacancy, the remaining members of the commission shall appoint an interim
25	successor to serve on the commission until the position is filled by the appointing
26	authority.
27	* * *
28	Section 2. This Act shall become effective upon signature by the governor or, if not
29	signed by the governor, upon expiration of the time for bills to become law without signature
30	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

- 1 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 2 effective on the day following such approval.

Abstract: Provides relative to the members of the boards of commissioners of the two areas of the Parish Hospital Service District for the parish of Orleans.

<u>Present law</u> (R.S. 46:1094) creates the Parish Hospital Service District for the parish of Orleans. Provides for the district's boundaries to be coterminous with the parish boundaries but divides the parish into two areas, each to be governed by a board of commissioners. The two areas are: (a) Orleans Parish east of the Industrial Canal and (b) all of Orleans Parish except the geographical areas east of the Industrial Canal and the area of Orleans Parish bounded by Earhart Boulevard, Carrollton Avenue, Loyola Avenue, and Iberville Street. <u>Proposed law</u> retains <u>present law</u>.

<u>Present law</u>, relative to the boards of commissioners for each of the two areas, provides that each board is comprised of 13 members. Provides that seven members are appointed by the parish chief executive officer and that they shall have expertise in certain areas outlined in <u>present law</u>. Proposed law retains the expertise requirement of <u>present law</u> and requires that three of the seven appointments be made from lists of nominations submitted by the member of the governing authority of New Orleans, the member of the La. House of Representatives, and the member of the La. Senate whose districts encompasses all or the greater portion of the area in which the district is located. <u>Proposed law</u> otherwise retains <u>present law</u>.

<u>Present law</u> provides that the eight appointed members serve at the pleasure of the parish chief executive officer and the five specified ex officio members serve during their terms in their respective offices. Provides for filling vacancies in the membership of the commission in the same manner as the original appointment. <u>Proposed law</u> reenacts <u>present law</u>.

Effective upon signature of governor or lapse of time for gubernatorial action.

(Amends R.S. 46:1095(B)(1); Reenacts R.S. 46:1095(C))

Summary of Amendments Adopted by House

Committee Amendments Proposed by <u>House Committee on Municipal, Parochial and</u> <u>Cultural Affairs</u> to the <u>original</u> bill.

1. Amends <u>present law</u> to remove expertise requirements applicable to seven of the appointed members and to add requirement that three of them be made from nominations.
