| 9 | Be it enacted by the Legislature of Louisiana: |
| 10 | Section 1. R.S. 2:705(I) and 706(F) are hereby amended and reenacted to read as |
| 11 | follows: |
| 12 | §705. Board of commissioners; creation; membership; terms; officers; meetings |
| 13 | * * * |
| 14 | I. The board shall hold regular monthly semiannual meetings and may hold |
| 15 | additional meetings as it deems necessary. A board member who fails to attend three |
| 16 | two consecutive meetings, or four or more meetings in a one-calendar-year period, |
| 17 | without being excused by the chairman of the board shall be removed for cause, and, |
| 18 | upon removal, that position shall be declared vacant and filled as provided in this |
| 19 | Section. All meetings of the board and all minutes and records thereof shall be |
| 20 | subject to the Open Meetings Law and the Public Records Act. A majority of the |
| 21 | members of the board shall constitute a quorum. A quorum shall be required for the |
| 22 | transaction of all business of the board. All actions of the authority shall be |
| 23 | approved by the affirmative vote of a majority of the members present and voting. |
