# ACT No. 351

HOUSE BILL NO. 358

BY REPRESENTATIVES GREENE, ABRAMSON, HENRY BURNS, CARTER, FOIL, GISCLAIR, HARDY, HOFFMANN, HONORE, LOPINTO, MONICA, RICHARD, RICHARDSON, SCHRODER, SEABAUGH, SIMON, GARY SMITH, JANE SMITH, ST. GERMAIN, TUCKER, AND WHITE AND SENATORS MURRAY, QUINN, AND WILLARD-LEWIS

Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

1 AN ACT

2 To enact R.S. 9:2800.22, relative to limitations of liability; to provide a limitation of liability  
3 for schools who enter into recreational joint-use agreements; to require insurance;  
4 to provide definitions; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 9:2800.22 is hereby enacted to read as follows:

7 §2800.22. Limitation of liability for use of school facilities

8 A. The governing authority of an elementary or secondary school or charter  
9 school who enters into a recreational joint-use agreement for use of its facility owes  
10 no duty of care to keep such premises safe for entry or use by others, pursuant to a  
11 joint-use agreement, outside of regularly scheduled school activities or to give a  
12 warning of any hazardous conditions, use of, structure, or activities on the premises.  
13 When the governing authority enters into a recreational joint-use agreement, it is not  
14 extending any assurance that the premises are safe or a duty of care, or assuming  
15 responsibility for or incurring liability for any injury, death, loss, civil penalty, or  
16 damages to persons or property caused by any act of a person to whom permission  
17 is granted.

18 B. This Section does not exclude any liability which would otherwise exist  
19 for injury or damages caused by gross negligence or willful and wanton misconduct.

20 C. When entering into a recreational joint-use agreement, the elementary or  
21 secondary school or charter school shall require in the agreement that the other entity

1 maintain and provide proof of adequate liability and accident insurance coverage as  
2 determined by industry standards.

3 D. As used in this Section, "recreational joint-use agreement" means a  
4 written agreement between the governing authority of an elementary, secondary, or  
5 charter school and a public or private entity, authorizing such entity to access the  
6 premises of a school under the governing authority's jurisdiction for the purposes of  
7 conducting or engaging in recreational activity.

8 E. The agreement shall set forth the conditions, terms, and requirements  
9 under which such authorization and use is granted, including that the entity shall  
10 indemnify and hold harmless the governing authority from any liability arising from  
11 such use, and that the governing authority may at any time and without cause revoke  
12 its authorization to use the premises and terminate the agreement.

13 Section 2. This Act shall become effective upon signature by the governor or, if not  
14 signed by the governor, upon expiration of the time for bills to become law without signature  
15 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If  
16 vetoed by the governor and subsequently approved by the legislature, this Act shall become  
17 effective on the day following such approval.
