## PROCUREMENT: Provides relative to procurement by certain institutions of higher education

7	Be it enacted by the Legislature of Louisiana:			
8	Section 1. R.S. 17:3139.5(B)(2)(d)(iii) is hereby enacted to read as follows:

2	the Louisiana Procurement Code in Title 39 of the Louisiana Revised Statutes of		
3	1950. For the purposes of this Item, the term "procurement" shall mean the buying,		
4	purchasing, renting, leasing, or otherwise obtaining any supplies, services, or major		
5	repairs. It also includes the extension or renewal of a contract for supplies, services,		
6	or repairs as well as all functions that pertain to obtaining of any public procurement,		
7	including description of requirements, selection and solicitation of sources, and the		
8	preparation and award of contract.

10	Section 2. The provisions of R.S. 17:3139.5(B)(2)(d)(i) and (ii) shall continue to		
11	apply to any procurement pending on the effective date of this Act. For the purposes of this		
12	Section, the term "procurement" shall have the same meaning as in R.S. 39:1556. The		
13	provisions of this Section shall not apply to any renewal or extension of a procurement		
14	contract in effect on the date this Act becomes effective.		
15	Section 3. The provisions of this Act shall become effective July 1, 2020.

Abstract: Revokes authority for Louisiana State University and Agricultural and Mechanical College (LSU) and LSU Health Sciences Center - health care services division to use the higher education procurement code, effective July 1, 2020.

<u>Present law</u> (R.S. 17:3139.5) grants privileges to institutions of higher education who achieve certain targets. <u>Proposed law</u> retains <u>present law</u>.

<u>Present law</u> provides that one of the benefits of meeting targets in <u>present law</u> is the authority to use a procurement code that is not the state's procurement code (R.S. 39:1551 et seq).

<u>Proposed law</u> revokes as of July 1, 2020, the authority of LSU and LSU Health Sciences Center - health care services division to utilize their own procurement code. Provides that any new procurement (defined as the buying, purchasing, renting, leasing, or otherwise obtaining any supplies, services, or major repairs) or extension or renewal of an existing contract commenced on or after July 1, 2020, must be done through the state procurement code. <u>Proposed law</u> further provides that any pending procurement or administration of a procurement contract in place on July 1, 2020, may continue to operate under the LSU procurement code until the contract terminates or is renewed or extended.
