ENVIRONMENT/LANDFILL: Exempts pulp and paper wastes from certain impoundment regulations

AN ACT

2 To amend and reenact R.S. 30:2160, relative to waste impoundments; to provide for 3 exemptions for wastes generated from pulp and paper waste production; and to 4 provide for related matters. 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. R.S. 30:2160 is hereby amended and reenacted to read as follows: 7 §2160. Bauxite waste Waste impoundments 8 A. The secretary, his designee, or the appropriate assistant secretary may 9 exempt from the regulations provided in this Chapter liners and final covers for 10 surface impoundments which receive spent bauxite and related waste resulting from 11 production of alumina, whether generated on-site or at a separate industrial site in 12 this state owned and operated by the same generator. 13 B. The secretary, his designee, or the appropriate assistant secretary shall 14 exempt surface impoundments that receive wastes resulting from the production of 15 pulp and paper generated on-site from the regulations promulgated pursuant to this 16 Chapter providing for liner, final cover, and closure and post-closure requirements. 17 The department shall promulgate rules implementing this Subparagraph and shall 18 provide that at the time of closure the department's rules and regulations providing 19 for facility post-closure requirements shall not apply to the following:

**Abstract:** Exempts surface impoundments that receive wastes resulting from the production of pulp and paper generated on-site from requirements for liner, final cover, and closure and post-closure.

<u>Present law</u> authorizes the secretary, his designee, or the appropriate assistant secretary to exempt requirements for liners and final covers for surface impoundments which receive spent bauxite and related waste. <u>Proposed law</u> retains <u>present law</u>.

<u>Proposed law</u> requires the secretary, his designee, or the appropriate assistant secretary to exempt requirements for liner, final cover, and closure and post-closure for surface impoundments that receive wastes resulting from the production of pulp and paper generated on-site.

<u>Proposed law</u> requires the department to promulgate rules implementing <u>proposed law</u> that provide that at the time of closure the facility post-closure requirements shall not apply to the following:

- (1) Solid wastes that are not subject to permitting requirements or processing or disposal standards by rules and regulations promulgated pursuant to this Chapter.
- (2) Solid waste managed pursuant to an approval beneficial use plan.
- (3) Materials listed in the May 1997 agreement established by the Louisiana Pulp and Paper Association-Louisiana Department of Environmental Quality Solid Waste Beneficial Use Work Group promulgated as LAC 33:VII.3017 (Appendix I).
