1 Section 2. This Act shall become effective upon signature by the governor or, if not

- 2 signed by the governor, upon expiration of the time for bills to become law without signature
- 3 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- 4 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 5 effective on the day following such approval.

Provides for net increases (decreases) as follows: State General Fund (Direct) by \$0; Interagency Transfers by \$141,614; Fees & Self-generated Revenues by (\$3,975,301); Statutory Dedications by (\$2,527,716); and Federal Funds by \$1,016,418.

Effective upon signature of the governor or lapse of time for gubernatorial action.
