2	To amend and reenact R.S. 47:301(16)(b)(ii) and 302(AA)(introductory paragraph) and to
3	enact R.S. 47:302(AA)(29) and 321.1(F)(67), relative to state sales and use tax; to
4	provide with respect to the exclusion for sales of certain precious metals and coins;
5	to provide for effectiveness and applicability of the exclusion; and to provide for
6	related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 47:301(16)(b)(ii) and 302(AA)(introductory paragraph) are hereby
9	amended and reenacted and R.S. 47:302(AA)(29) and 321.1(F)(67) are hereby enacted to
10	read as follows:
11	§301. Definitions
12	As used in this Chapter the following words, terms, and phrases have the
13	meaning ascribed to them in this Section, unless the context clearly indicates a

21	R.S. 47:302, 321, and 331, gold, silver, or numismatic coins, or platinum,
22	(aa) Platinum, gold, or silver bullion, that is valued solely upon its precious
23	metal content, whether in coin or ingot form.

24	F. Notwithstanding any other provision of law to the contrary, including but
25	not limited to any contrary provision of this Chapter, there shall be no exemptions
26	or exclusions as defined in R.S. 47:301 to the tax levied pursuant to the provisions
27	of this Section, except for the sales or purchases of the following items:

29	(66) Beginning July 1, 2016, in addition to those exclusions and exemptions
30	provided for in Paragraphs (1) through (65) of this Subsection, the following

This Act shall become effective upon signature by the governor or, if not 14 signed by the governor, upon expiration of the time for bills to become law without signature 15 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 16 vetoed by the governor and subsequently approved by the legislature, this Act shall become 17 effective on the day following such approval.
