Abstract: Increases the amount of an individual sewage fee imposed by the office of public health.

<u>Present law</u> provides that the department shall charge and collect a one-time fee of \$100 for each individual-type sewerage system installed for residential use.

Proposed law increases the fee from \$100 to \$150.

<u>Proposed law</u> corrects the terms "franchise" and "sale" to "franchisee" and "seller" to fit with the meaning of <u>present law</u>.

Proposed law makes technical changes and corrects a citation.

Effective upon signature of governor or lapse of time for gubernatorial action.
