APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment in the matter of "Allen Washington and Sandra Washington, et al v. State of Louisiana DOTD, et al"

AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2013-3 2014 to be used to pay the consent judgment in the suit entitled "Allen Washington 4 and Sandra Washington, individually and on behalf of their minor children: Allen 5 Washington, Jr., Samantha Washington and Allandra Washington v. State of 6 Louisiana through the Department of Transportation and Development, Jermaine 7 Brisco, Bayou Steel Corporation, and ABC Insurance Company"; and to provide for 8 related matters. 9 Be it enacted by the Legislature of Louisiana: 10 Section 1. The sum of One Million Five Hundred Thousand and No/100 11 (\$1,500,000.00) Dollars, is hereby appropriated out of the General Fund of the state of 12 Louisiana for Fiscal Year 2013-2014 to be used to pay the consent judgment in the suit 13 entitled "Allen Washington and Sandra Washington, individually and on behalf of their 14 minor children: Allen Washington, Jr., Samantha Washington and Allandra Washington v. 15 State of Louisiana through the Department of Transportation and Development, Jermaine 16 Brisco, Bayou Steel Corporation, and ABC Insurance Company", bearing Number 60,176, 17 Division "D" on the docket of the Twenty-Ninth Judicial District Court, parish of St. 18 Charles, state of Louisiana.

- 1 Section 2. This Act shall become effective on July 1, 2013; if vetoed by the governor
- 2 and subsequently approved by the legislature, this Act shall become effective on July 1,
- 3 2013, or on the day following such approval by the legislature, whichever is later.
