8	Section 1. R.S. 39:1649 is hereby enacted to read as follows:
9	§1649. Medicaid managed care contracts for behavioral health services
10	A. For purposes of this Section, the following terms have the meaning
11	ascribed to them in this Subsection:
12	(1) "Behavioral health services" and "behavioral health services provider"
13	shall have the meaning ascribed in R.S. 40:2153.
14	(2) "Department" means the Louisiana Department of Health.
15	(3) "Managed care organization" shall have the meaning ascribed in R.S.

17	B. No Medicaid managed care organization shall deny a behavioral health
18	services provider licensed by the department the opportunity to be a participating

**Abstract:** Prohibits Medicaid managed care organizations from denying licensed and qualified behavioral health services providers the opportunity to enroll in provider networks.

<u>Proposed law</u> provides that no Medicaid managed care organization shall deny a behavioral health services provider licensed by the La. Department of Health the opportunity to be a participating provider in the provider network of the managed care organization if the behavioral health services provider meets all requirements of participation in the state Medicaid program.
