6	grant the board of supervisors the authority the increase fee amounts; to subject the
7	authority to increase fee amounts to the approval of the Joint Legislative Committee
8	on the Budget; to provide for an effective date; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. R.S. 17:3351.21 is hereby enacted to read as follows:

12	Mechanical College; Louisiana State University at Alexandria; aviation
13	program; course fees; amounts; authority to increase
14	A. In addition to the authority granted by any other provision of law and in
15	accordance with Article VII, Section 2.1 of the Constitution of Louisiana, the Board
16	of Supervisors of Louisiana State University and Agricultural and Mechanical
17	College may impose at Louisiana State University at Alexandria the following
18	aviation course fees:
19	(1) Private Pilot Flight I: \$4,600.
20	(2) Private Pilot Flight II: \$4,600.

17	vetoed by the governor and subsequently approved by the legislature, this Act shall become
18	effective on the day following such approval.

<u>Proposed law</u> authorizes the LSU Board of Supervisors to impose specified course fees for 10 aviation courses at LSU-Alexandria beginning with the Fall 2021 semester. Provides the specific fee for each course. Authorizes the board to increase the amount of each fee, subject to the approval of the Joint Legislative Committee on the Budget.

Effective upon signature of governor or lapse of time for gubernatorial action.
