HOUSE BILL NO. 414

1 AN ACT

2 To amend and reenact Code of Criminal Procedure Article 814(A)(26) and (27), relative to  
3 responsive verdicts; to provide changes in responsive verdicts for theft and attempted  
4 theft; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. Code of Criminal Procedure Article 814(A)(26) and (27) are hereby  
7 amended and reenacted to read as follows:

8 Art. 814. Responsive verdicts; in particular

9 A. The only responsive verdicts which may be rendered when the indictment  
10 charges the following offenses are:

11 \* \* \*

12 26. Theft:

13 Guilty of theft of property having a value of one thousand five hundred  
14 dollars or more.

15 Guilty of theft of property having a value of five hundred dollars or more, but  
16 less than one thousand five hundred dollars.

17 ~~Guilty of theft of property having a value of three hundred dollars or more,~~  
18 ~~but less than five hundred dollars.~~

19 Guilty of theft of property having a value of less than ~~three~~ five hundred  
20 dollars.

21 Guilty of attempted theft of property having a value of one thousand five  
22 hundred dollars or more.

23 Guilty of attempted theft of property having a value of ~~three~~ five hundred  
24 dollars or more, but less than one thousand five hundred dollars.

1 Guilty of attempted theft of property having a value of less than ~~three~~ five  
2 hundred dollars.

3 Guilty of unauthorized use of movables having a value in excess of five  
4 hundred dollars.

5 Guilty of unauthorized use of movables having a value of five hundred  
6 dollars or less.

7 Not guilty.

8 27. Attempted Theft:

9 Guilty of attempted theft of property having a value of one thousand five  
10 hundred dollars or more.

11 Guilty of attempted theft of property having a value of ~~three~~ five hundred  
12 dollars or more, but less than one thousand five hundred dollars.

13 Guilty of attempted theft of property having a value of less than ~~three~~ five  
14 hundred dollars.

15 Guilty of attempted unauthorized use of movables having a value of less than  
16 one hundred dollars.

17 Guilty of attempted unauthorized use of movables having a value in excess  
18 of five hundred dollars.

19 Guilty of attempted unauthorized use of movables having a value of five  
20 hundred dollars or less.

21 Not guilty.
