MTR VEHICLE/LICEN PLATES: Creates a special "For Hire" license plate for use in the city of New Orleans

1 AN ACT 2 To enact R.S. 47:469.1, relative to special license plates; to create a special "For Hire" plate 3 for use in the city of New Orleans; to provide for the design and cost; to provide for 4 rules and regulations; and to provide for related matters. 5 Notice of intention to introduce this Act has been published as provided by Article III, Section 13 of the Constitution of 6 Louisiana. 7 8 Be it enacted by the Legislature of Louisiana: 9 Section 1. R.S. 47:469.1 is hereby enacted to read as follows: 10 §469.1. Special license plate; "For Hire"; city of New Orleans 11 A. Taxi cabs, limousines, horse drawn carriages, and pedicabs owned or 12 operated by companies licensed by the city of New Orleans, shall be issued a special 13 "For Hire" plate. 14 B. The plate shall be designated with a series consisting of numeric 15 characters, alpha characters, or any combination thereof. The series shall be 16 consistent with the license number issued by the city of New Orleans to identify the 17 vehicle and may be accompanied by a symbol or emblem representing the city of 18 New Orleans, taxi cab bureau. 19 C.(1) The city of New Orleans shall provide the office of motor vehicles with the series to be issued to the vehicles. All plates authorized by this Section shall 20 21 include a handling charge of three dollars and fifty cents, as authorized by R.S.

12	license number issued by the city of New Orleans to identify the vehicle and may be
13	accompanied by a symbol or emblem representing the city of New Orleans, taxi cab
14	bureau. The city of New Orleans shall provide the office of motor vehicles with the
15	series to be issued to the vehicles.
16	(3) In addition to the three dollars and fifty cents as authorized by R.S.
17	47:463(A)(3)(a), the annual rate for the plate shall be thirty dollars.
18	E. Permissible road usage of horse drawn carriages and pedicabs shall be
19	determined by New Orleans city ordinances.
20	F. The commissioner is authorized to promulgate all rules and regulations
21	necessary, in accordance with the Administrative Procedure Act, to administer and
22	enforce the provisions of this Section.

Brossett HB No. 425

Abstract: Creates the special "For Hire" plate to be used by taxis, limousines, horse drawn carriages, and pedicabs operating in New Orleans.

<u>Proposed law</u> provides that taxis, limousines, horse drawn carriages, and pedicabs operating in the city of New Orleans shall be issued a special "For Hire" plate.

<u>Proposed law</u> provides that the city of New Orleans shall provide the office of motor vehicles with the series designation to be placed on each plate. Requires taxis and limousines to have two plates, one in front and one on the back, at an annual cost of \$50 for the two plates. Also provides for a handling fee of \$3.50.

<u>Proposed law</u> provides that horse drawn carriages and pedicabs shall be required to have only one plate at an annual cost of \$30, with a handling fee of \$3.50.

<u>Proposed law</u> authorizes the commissioner of motor vehicles to promulgate rules and regulations.
