RETIREMENT/STATE EMPS: Provides relative to membership of the LASERS, TRSL, and LSERS boards of trustees

AN ACT

2	To amend and reenact R.S. 11:511, 822(A) and (B), 1162(A), 1164, and 1302(A), relative
3	to certain state retirement systems; to provide relative to the membership of the
4	boards of trustees of the Louisiana State Employees' Retirement System, the
5	Teachers' Retirement System of Louisiana, the State Police Pension and Retirement
6	System, and the Louisiana School Employees' Retirement System; to provide for
7	effectiveness; and to provide for related matters.
8	Notice of intention to introduce this Act has been published
9	as provided by Article X, Section 29(C) of the Constitution
10	of Louisiana.
11	Be it enacted by the Legislature of Louisiana:
12	Section 1. R.S. 11:511, 822(A) and (B), 1162(A), 1164, and 1302(A) are hereby
13	amended and reenacted to read as follows:
14	§511. Composition of board of trustees
15	The board of trustees shall consist of twelve thirteen members, as follows:
16	(1) The chairman of the Retirement Committee of the House of
17	Representatives, ex officio, or his designee.
18	(2) The chairman of the Retirement Committee of the Senate, ex officio, or
19	his designee.

(3) The treasurer of the state of Louisiana, ex officio, or his designee.

(4) The commissioner of administration, ex officio, or his designee.

(5) Six trustees who shall be active employees and members of the system with at least ten years of creditable service and who shall be elected by the members of the system for a term of four years to succeed members whose terms expire under rules and regulations adopted by the board to govern the elections. However, those trustees whose terms begin on or after January 1, 1998, shall be eligible to serve only three consecutive four-year terms, to include any term served as an active or retired member. Upon the completion of the third consecutive four-year term, the trustee shall be ineligible for a fourth consecutive term of office. An active member who retires while serving on the board shall be allowed to remain on the board for the remainder of the term for which elected. The director, assistant directors, chief investment officer, and other employees of the staff of the system shall be ineligible for membership on the board, and no member of the board elected under this Section shall be eligible for one of these positions for a period of two years after the termination of their service on the board. No department in the executive branch of state government, as more particularly described in Title 36 of the Louisiana Revised Statutes of 1950, as amended and revised, may have more than two trustees serving on the board at the same time. The candidate or candidates who have received the highest and next highest vote tallies, and who do not violate the prohibition against more than two trustees serving from the same department, shall be declared the elected trustee or trustees.

(5) (6) Three trustees who are retired members of the system and who shall represent the retired members of the system. The retired trustees shall be elected by the retired members of the system for a term of four years. However, those trustees whose terms begin on or after January 1, 1998, shall be eligible to serve only three consecutive four-year terms, to include any term served as an active or retired member. Upon the completion of the third consecutive four-year term, the trustee shall be ineligible for a fourth consecutive term of office. The election shall be held

in accordance with the rules adopted by the board to govern the elections of trustees. 2 Vacancies shall be filled in accordance with R.S. 11:512. 3 §822. Members of board of trustees; appointment or election; terms of office; 4 5 vacancies; compensation A. 15	(8) (9) Two voting members to represent the retired teachers shall be elected
16	by a majority of those voting retired members of the Teachers' Retirement System
17	of Louisiana for a four-year term.
18	(9) (10) One voting member, who shall be a parish or city superintendent
19	of schools, shall be elected by all parish and city superintendents of schools in
20	Louisiana, for a four-year term.
21	B. There shall be no restriction as to type of employment or position held as
22	a qualification for any member seeking election under Paragraphs $\frac{(6)}{(7)}$ through $\frac{(8)}{(8)}$
23	(9) of Subsection A of this Section; however, an elected member of the board who
24	has served at least twelve months of his term shall be eligible to continue as a
25	member of the board following the effective date of his retirement from the system,
26	until the expiration of the term for which he was elected; however, no elected
27	member of the board shall be eligible to continue as a member of the board after
28	December thirty-first following any change in his principal residence, employment,

1	or status which would otherwise render him ineligible to become a candidate for the
2	position to which he was previously elected.

4	§1162. Members of board of trustees; appointment or election; terms of office;
5	vacancies; compensation
6	A. The board shall consist of eleven such trustees, as follows:
7	(1) President of the Louisiana School Bus Operators' Association, ex officio.
8	(2) Chairman of the Appropriations Retirement Committee of the House of
9	Representatives, ex officio, or his designee.
10	(3) Chairman of the Retirement Committee of the Senate, ex officio, or his
11	designee.
12	(4) The secretary of state, ex officio, or his designee.
13	(5) The state treasurer, ex officio, or his designee.
14	(6) The commissioner of administration, ex officio, or his designee.
15	$\frac{(6)(a)}{(7)(a)}$ Four members of the system shall be elected by the members
16	of the retirement system for a term of four years each, according to such rules and
17	regulations as the board of trustees shall adopt to govern such elections. Except as
18	otherwise provided in this Paragraph, each board member shall be a resident of the
19	district represented. The districts will elect a member for a four-year term with the
20	elections staggered so as to elect one member each year. Participation in the
21	Deferred Retirement Option Plan shall not cause a member to be ineligible for
22	candidacy in an election for the active member position on the board of trustees.
23	Any member of this system who is elected to serve as a representative of the active
24	members on the board of trustees and who, after such election, either commences
25	participation in the Deferred Retirement Option Plan or retires shall not have his
26	term of office as a trustee affected by either of those events.
27	(b) Beginning March 1, 1997, and until December 31, 2008, the districts
28	shall be composed of the following parishes:

1	(i) District 1: Assumption, Jefferson, Lafourche, Orleans, Plaquemines, St.
2	Bernard, St. Charles, St. James, St. John the Baptist, and Terrebonne.
3	(ii) District 2: Ascension, East Baton Rouge, East Feliciana, Iberville,
4	Lafayette, Livingston, St. Helena, St. Martin, St. Tammany, Tangipahoa,
5	Washington, West Baton Rouge, and West Feliciana.
6	(iii) District 3: Bienville, Bossier, Caddo, Caldwell, Catahoula, Claiborne,
7	Concordia, DeSoto, East Carroll, Franklin, Jackson, LaSalle, Lincoln, Madison,
8	Morehouse, Ouachita, Red River, Richland, Tensas, Union, Webster, West Carroll,
9	and Winn.
10	(iv) District 4: Acadia, Allen, Avoyelles, Beauregard, Calcasieu, Cameron,
11	Evangeline, Grant, Iberia, Jefferson Davis, Natchitoches, Pointe Coupee, Rapides,
12	Sabine, St. Landry, St. Mary, Vermilion, and Vernon.
13	(c) Each member elected pursuant to this Paragraph who takes office on or
14	after January 1, 2009, shall be elected from districts composed as provided in this
15	Subparagraph. Each member serving on December 31, 2008, who was elected to
16	represent a district as provided in Subparagraph (b) of this Paragraph shall represent
17	the district as provided in this Subparagraph having the same number designation as
18	the district as provided in Subparagraph (b) of this Paragraph from which the
19	member was elected until the expiration of his term of office, whether or not he is
20	a resident of the district as provided in this Subparagraph. Each successor of a
21	member serving on December 31, 2008, who was elected to represent a district as
22	provided in Subparagraph (b) of this Paragraph shall be elected from the district as
23	provided in this Subparagraph having the same number designation and shall be a
24	resident of the district as provided in this Subparagraph. On January 1, 2009, and
25	thereafter, the districts shall be composed of the following parishes:
26	(i) District 1: Assumption, Iberia, Iberville, Jefferson, Lafayette, Lafourche,
27	Orleans, Plaquemines, St. Bernard, St. Charles, St. James, St. John the Baptist, St.

Martin, St. Mary, and Terrebonne.

1	(ii) District 2: Ascension, East Baton Rouge, East Feliciana, Livingston, St.
2	Helena, St. Tammany, Tangipahoa, Washington, West Baton Rouge, and West
3	Feliciana.
4	(iii) District 3: Bienville, Bossier, Caddo, Caldwell, Catahoula, Claiborne,
5	Concordia, East Carroll, Franklin, Jackson, Lincoln, Madison, Morehouse, Ouachita,
6	Richland, Tensas, Union, Webster, and West Carroll.
7	(iv) District 4: Acadia, Allen, Avoyelles, Beauregard, Calcasieu, Cameron,
8	Desoto DeSoto, Evangeline, Grant, Jefferson Davis, LaSalle, Natchitoches, Pointe
9	Coupee, Rapides, Red River, Sabine, St. Landry, Vermilion, Vernon, and Winn.
10	(7) (8) Two retired members elected at large by the retirees of the retirement
11	system, provided the members' terms of office are for the same duration, but
12	staggered so that the beginning and ending years of each member's term are not on
13	the same year, and the member's terms and elections shall be governed according to
14	rules and regulations adopted by the board of trustees.

16	§1164. Voting power of trustees; votes necessary for action of board
17	Each trustee shall be entitled to one vote in the board. Five Six votes shall
18	be necessary for a decision by the trustees at any meeting of the board.
19	* * *
20	§1302. Creation and composition of board; powers; expenses of administration
21	A. The State Police Retirement Board is created and is composed of the
22	following members:
23	(1) The state treasurer, ex officio, or his designee.
24	(2) The commissioner of administration, ex officio, or his designee.
25	(3) The superintendent of the office of state police, ex officio, or his
26	designee.
27	(4) The president of the Louisiana State Troopers' Association, ex officio.
28	(5) The president of the Central State Troopers' Coalition, ex officio.

1	(6) The chairman of the Retirement Committee of the House of
2	Representatives of the Louisiana Legislature, ex officio, or his designee.
3	(7) The chairman of the Retirement Committee of the Senate of the
4	Louisiana Legislature, ex officio, or his designee.
5	(8) One member of the system, who has credit for at least five years of
6	service at the time of taking office, to be elected at large by a majority of votes cast
7	by the active members of the system.
8	(9) One member of the system, who is a retiree at the time of taking office,
9	to be elected at large by a majority of votes cast by the retired members of the
10	system.
11	(10) One member of the system who has credit for at least five years of
12	service at the time of taking office, or who is a retiree at the time of taking office, to
13	be elected at large by a majority of votes cast by the active and retired members of
14	the system.
15	(11) One surviving spouse of a deceased member to be elected at large by
16	a majority of votes cast by the active and retired members of the system.
17	* * *
18	Section 2. This Act shall become effective on July 1, 2011; if vetoed by the governor
19	and subsequently approved by the legislature, this Act shall become effective on July 1,
20	2011, or on the day following such approval by the legislature, whichever is later.

Kleckley HB No. 426

Abstract: Relative to the four state retirement systems: the La. State Employees' Retirement System (LASERS), Teachers' Retirement System of La. (TRSL), La. School Employees' Retirement System (LSERS), and the State Police Pension and Retirement System (STPOL). Adds the commissioner of administration or his designee to LASERS, TRSL, and LSERS. Makes technical changes with regards to ex officio members and allows for the appointment of designees for all ex officio members of the boards of trustees of LASERS, TRSL, LSERS, and STPOL.

<u>Present law</u> provides relative to the membership of the boards of LASERS, TRSL, LSERS, and STPOL.

<u>Proposed law</u> adds the commissioner of administration or his designee to the membership of LASERS, TRSL, and LSERS.

<u>Present law</u> permits various individuals to serve on the boards of LASERS, TRSL, LSERS, and STPOL by virtue of their office.

<u>Proposed law</u> clarifies that all such members shall be "ex officio" members and further provides that all such members may appoint designees to serve on the boards.

<u>Present law</u> relative to LSERS, provides that the chairman of the appropriations committee of the House of Representatives and the chairman of the retirement committee of the House of Representatives shall serve on the board.

<u>Proposed law</u>, removes the chairman of the Appropriations Committee of the House of Representatives from the LSERS board.

Effective July 1, 2011.

(Amends R.S. 11:511, 822(A) and (B), 1162(A), 1164, and 1302(A))

### Summary of Amendments Adopted by House

Committee Amendments Proposed by <u>House Committee on Retirement</u> to the <u>original</u> bill.

1. Added change to the TRSL board authorizing the state superintendent of education to appoint any designee to such board, not just his first assistant.

#### House Floor Amendments to the engrossed bill.

- 1. Provides that all ex officio members of the boards of trustees of such retirement systems may appoint a designee to serve on those boards.
- 2. Removes the chairman of the appropriations committee of the House of Representatives from the LSERS board; replaces him with the chairman of the House Committee on Retirement.
