MTR VEHICLE/VIOLATIONS: Provides relative to the disqualification of commercial driver's licenses

AN ACT

2	To amend and reenact R.S. $32:393(B)(2)$ and $(C)(1)(b)$ and $414.2(A)(1)(c)$ and to enact R.S.
3	32:414.2(A)(1)(d)(xi), relative to commercial driver's licenses; to provide for reports
4	to be sent to the Department of Public Safety and Corrections regarding violations
5	by holders of commercial driver's licences; to provide relative to the disqualification
6	of commercial driver's licenses; to provide for definitions; and to provide for related
7	matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 32:393(B)(2) and (C)(1)(b), and 414.2(A)(1)(c) are hereby amended
10	and reenacted and R.S. 32:414.2(A)(1)(d)(xi) is hereby enacted to read as follows:
11	§393. Persons charged with traffic violations; time for disposition, licenses, reports,
12	and records to be sent to Department of Public Safety and Corrections, fee
13	charged; record of unpaid traffic fines and parking fines

29	(c) As used in this Section;:

1	(i) "alcohol Alcohol concentration" shall mean the concentration of alcohol
2	in a person's blood, breath, or urine, or other bodily substance. When expressed as
3	a percentage, alcohol concentration means the numbers of grams of alcohol per one
4	hundred milliliters of blood, the number of grams of alcohol per two hundred ten
5	liters of breath, the number of grams of alcohol per sixty-seven milliliters of urine,
6	or their equivalents.
7	(ii) "Commercial driver's license" shall mean a commercial driver's license,
8	a commercial learner's permit, or both, held by a person even if the holder of a
9	commercial learner's permit holds a commercial driver's license for a class lower
10	than the class for which he holds a commercial learner's permit.
11	(d) For the purposes of this Section, when operating a commercial motor
12	vehicle, "serious traffic violation" means conviction of any of the following:

14	(xi) Use of a handheld mobile telephone while driving a commercial motor
15	vehicle. For purposes of this Item, "driving" shall include all times that a
16	commercial motor vehicle is being operated on the highway, including while the
17	vehicle is stationary on the highway due to traffic, a traffic control device, or other
18	momentary delays, but shall not include times when the vehicle is pulled to the side
19	of, or off of, a highway, and is halted in a location where the vehicle can remain
20	safely stationary.

Shadoin HB No. 465

Abstract: Requires court or district attorneys to send specific records pertaining to commercial driver's license holders to the Dept. of Public Safety and Corrections, public safety services, within a certain amount of time. Provides for additional disqualification offenses for commercial driver's licences and definitions.

Present law provides that whenever the driver's license of any person is mandatorily suspended under the provisions of present law, the court in which the conviction is had or

in which bail is forfeited shall attach the license to a record of the conviction or bail forfeiture and shall forward both to the Dept. of Public Safety.

<u>Proposed law</u> retains <u>present law</u> and makes technical correction to reflect that the record shall be sent to the Dept. of Public Safety and Corrections (DPS&C), public safety services, instead of the Dept. of Public Safety.

<u>Present law</u> requires a court or district attorney to send an abstract of a report to the DPS&C, public safety services, for every driver who is convicted and sentenced, forfeits bail as a result of a final judgment of forfeiture, or other final disposition made, except for convictions relating to parking violations, not later than 30 days after the conviction and sentencing thereupon, forfeiture of bail and final judgment of forfeiture, or the final disposition of his case.

<u>Proposed law</u> retains <u>present law</u> for persons who hold Class "D", "E", or both, licenses, but requires the court or district attorney to send the same information to DPS&C, public safety services, within ten days and in an electronic format for persons who hold commercial driver's licenses or permits, or both.

Proposed law defines "commercial driver's license" for purposes of present law.

<u>Present law</u> provides for a series of offenses constituting "serious traffic violations" for which the conviction of can disqualify the holder of a commercial driver's from driving commercial motor vehicles.

<u>Proposed law</u> adds use of a handheld mobile telephone while driving a commercial motor vehicle to the list of serious traffic violations in <u>present law</u> and defines "driving" for purposes of <u>proposed law</u>.
