2 To amend and reenact R.S. 9:4815(A)(introductory paragraph), relative to the Private Works

Act; to provide relative to certain contractual requirements; to prohibit the waiver of

certain contractual escrow requirements; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 9:4815(A)(introductory paragraph) is hereby amended and reenacted

§4815. Escrow of funds due under contract; procedures

A. When, under the provisions of this Part, a contract in the amount of fifty thousand dollars or more is entered into between an owner and a contractor and if in accordance with the terms of such contract funds earned by the contractor are withheld as retainage by the owner from periodic payments due to the contractor then such funds shall be deposited by the owner into an interest bearing escrow account. No contractor may be required to waive any such requirement. The provisions of this Section shall not apply to a contract for a single family residence or double family residence. The provisions of this Section also shall not apply to a contract for the construction or improvement of the following types of industrial facilities that are, or will be, engaged in activities defined or classified under one or more of the following subsectors, industry groups, or industries of the 1997 North American Industry Classifications System (NAICS):

Abstract: Relative to the Private Works Act, prohibits the waiver of contractual requirements that retainage funds be deposited by the owner into an interest bearing escrow account.

<u>Present law</u> provides, relative to the Private Works Act, that when a contract in the amount of \$50,000 or more is entered into between an owner and a contractor and funds earned by the contractor are withheld as retainage by the owner from periodic payments due to the contractor then such funds shall be deposited by the owner into an interest bearing escrow account.

<u>Proposed law</u> retains <u>present law</u> and specifies that no contractor may be required to waive the requirement that the funds be deposited by the owner into an interest bearing escrow account.
