SCHOOLS/EMPLOYEES: Provides eligibility for sabbatical leave for certified school nurses, audiologists, educational diagnosticians, and speech-language pathologists employed by state special schools and by city, parish, and other local public school systems

AN ACT

2	To amend and reenact R.S. 17:46(A)(1)(b) and 1170, relative to school employees; to
3	provide eligibility for sabbatical leaves to certified school nurses, audiologists
4	educational diagnosticians, and speech-language pathologists employed by state
5	special schools and by city, parish, and other local public school systems; to provide
6	for limitations on such eligibility with respect to fiscal conditions; and to provide for
7	related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 17:46(A)(1)(b) and 1170 are hereby amended and reenacted to read

§1170. Definitions

As used in this Subpart, the words "teacher" or "teaching staff" shall include any person employed by a city, parish, or other local public school board in the state of Louisiana who holds a valid teaching certificate issued by the state Department of Education and any social worker, guidance counselor, school nurse, audiologist, educational diagnostician, speech-language pathologist, or school psychologist employed by a city, parish, or other local public school board in the state who holds, as applicable, a the appropriate valid professional ancillary certificate in school social work, guidance counseling, or school psychology issued by the state Department of Education. Section 2. School nurses, speech-language pathologists, audiologists, and educational diagnosticians shall be eligible for leave as provided in R.S. 17:46(A)(1)(b) and 1170 only in a fiscal year for which the amount of the state and local base per pupil cost determination, as established in the minimum foundation program formula most recently approved by the legislature, is increased at least two and three quarters percent over the amount established for the previous fiscal year.

Hoffmann HB No. 468

**Abstract:** Adds certified school nurses, audiologists, educational diagnosticians, and speech-language pathologists to list of school employees eligible for sabbatical leave.

<u>Present law</u> provides that certain teaching staff of the state special schools or of city, parish, or other local public school boards are eligible for sabbatical leave. Includes social workers, guidance counselors, and school psychologists holding valid professional ancillary certificates issued by the state Dept. of Education. <u>Proposed law</u> adds school nurses, audiologists, educational diagnosticians, and speech-language pathologists who hold such certificates to the list of eligible employees but limits their eligibility to a fiscal year for which the amount of the state and local base per pupil cost determination, as established in the minimum foundation program (MFP) formula most recently approved by the legislature, is increased at least 2.75% over the amount established for the previous fiscal year.

## Summary of Amendments Adopted by House

Committee Amendments Proposed by <u>House Committee on Education</u> to the <u>original</u> bill.

- 1. Adds audiologists, educational diagnosticians, and speech-language pathologists to the list of school employees eligible for sabbatical leave.
- 2. Limits sabbatical eligibility of all employees added by <u>proposed law</u> to fiscal years that meet certain conditions.
