1	AN ACT
2	To enact R.S. 38:2212.8 and Chapter 24 of Title 39 of the Louisiana Revised Statutes of
3	1950, to be comprised of R.S. 39:2181 and 2182, relative to procurement; to prohibit
4	public entities from contracting with dealers who do not possess a valid dealer
5	license issued by the Louisiana Motor Vehicle Commission; to require proof of
6	certain dealers licenses; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 38:2212.8 is hereby enacted to read as follows:
9	§2212.8. Prohibition of bids from or contracts with unlicensed dealers
10	A. A public entity shall not accept any bid from or enter into any contract or
11	cooperative endeavor agreement, or any other transaction for the procurement of
12	vehicles, with a dealer who does not possess a valid dealer's license issued under the
13	provisions of R.S. 32:1254.
14	B. A public entity shall require that any bid submitted by, or a contract or
15	cooperative endeavor agreement with, a dealer for the purchase of vehicles shall
16	include a copy of a valid dealer's license issued under the provisions of R.S. 32:1254.
17	C. A public entity shall reject any bid submitted by a dealer for the purchase
18	of vehicles which does not include a copy of a valid dealer license.
19	D. A public entity shall not sign a contract or cooperative endeavor
20	agreement with a dealer for the purchase of vehicles which does not include a copy
21	of a valid dealer license.
22	E. If in the course of an audit or review by the legislative auditor, pursuant
23	to the powers and duties in R.S. 24:513, a violation of this Section is found, the

5	CHAPTER 24. PROHIBITIONS IN PUBLIC GOVERNMENTAL
6	CONTRACTS AND PROCUREMENT
7	<u>§2181. Applicability; definitions</u>
8	A. This Chapter shall apply to any contract or cooperative endeavor
9	agreement that results from any bid or other award governed under Chapter 16 and
10	Chapter 17 of this Title.
11	B. For the purpose of this Chapter, "public entity" shall mean any agency,
12	board, commission, department, or public corporation of the state, created by the
13	constitution or statute or pursuant thereto, or any political subdivision of the state,
14	including but not limited to any political subdivision as defined by Article VI,
15	Section 44 of the Constitution of Louisiana, and any public housing authority, public
16	school board, or any public officer whether or not an officer of a public corporation
17	or political subdivision.
18	<u>§2182.</u> Prohibition of bids from or contracts with unlicensed dealers
19	A. A public entity shall not accept any bid from or enter into any contract or
20	cooperative endeavor agreement, or any other transaction for the procurement of
21	vehicles, with a dealer who does not possess a valid dealer's license issued under the
22	provisions of R.S. 32:1254.
23	B. A public entity shall require that any bid submitted by, or a contract or
24	cooperative endeavor agreement with, a dealer for the purchase of vehicles shall
25	include a copy of a valid dealer's license issued under the provisions of R.S. 32:1254.
26	C. A public entity shall reject any bid submitted by a dealer for the purchase
