MTR VEHICLE/DRIVER LIC: Provides relative to the issuance and possession of drivers' licenses

AN ACT

2	To amend and reenact R.S. 32:411(F)(1) and 412(D)(6) and to enact R.S. 32:411(F)(3),
3	relative to the issuance and possession of drivers' licenses; to provide for the issuance
4	of a digitized driver's license; to provide new requirements for the issuance of a
5	driver's license that was renewed by mail or electronic commerce; and to provide for
6	related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 32:411(F)(1) and 412(D)(6) are hereby amended and reenacted and
9	R.S. 32:411(F)(3) is hereby enacted to read as follows:
10	§411. Deposit of license in lieu of security upon arrest; receipt; licensee to have
11	license or receipt in immediate possession; notification to vehicle owner;
12	surrender of license; issuance of temporary permits

14	F.(1) The licensee shall have his license, or a digitized driver's license as
15	provided in this Section, in his immediate possession at all times when driving a
16	motor vehicle and shall display it upon demand of any officer or agent of the
17	department or any police officer of the state, parish, or municipality, except that
18	where the licensee has previously deposited his license as provided in Subsection C
19	of this Section, and has received a receipt, as provided in Subsection D of this
20	Section, the licensee shall display the receipt upon demand of any officer or agent

of the department or any police officer of the state, parish, or municipality, the same to serve as a substitute for the license until the license is returned to the licensee. However, when an officer or agent of the department or any police officer of the state, or any parish or municipality has reasonable grounds to believe a person has committed an offense of driving without a valid driver's license in his possession, the police officer shall make every practical attempt based on identifying information provided by the person to confirm that the person has been issued a valid driver's license. If the police officer determines that the person has been issued a valid driver's license which is neither under revocation, suspension, or cancellation, but that the license is not in his possession, the peace officer shall issue a written summons to the offender in accordance with law, commanding him to appear and answer the charge.

- (3)(a) For the purposes of this Paragraph, a digitized driver's license shall mean a data file available on any mobile device which has connectivity to the internet through an application which allows the mobile device to download the data file from the department or an authorized representative of the department, which contains all of the data elements visible on the face and back of the license, and also displays the current status of the license. For the purposes of this Subparagraph, "current status" shall include but is not limited to valid, expired, cancelled, suspended, disqualified, hardship, or interlock hardship status.
- (b) A digital copy, photograph, or image of a driver's license which is not downloaded through the application on a mobile device shall not be a valid digitized driver's license as provided by this Section.
- (c) If a person is unable to produce a physical driver's license issued by the department, in connection with a traffic stop or checkpoint, the person may present a digitized driver's license to a law enforcement officer and shall not be issued any citation for driving a motor vehicle without a valid license in his possession. Except as provided in this Paragraph, a law enforcement officer or a representative of the

13	driver's license, the law enforcement officer shall promptly return the mobile device
14	to the person once he has had an opportunity to verify the identity and license status

**Abstract:** Provides for the issuance of a digitized driver's license and new requirements for the issuance of a driver's license that was renewed by mail or electronic commerce.

<u>Present law</u> requires that a licensee have his license in his immediate possession at all times when driving a motor vehicle.

<u>Proposed law modifies present law</u> by authorizing a licensee to have a digitized driver's license provided by the Dept. of Public Safety and Corrections, office of motor vehicles, as an alternative to his physical license.

<u>Proposed law</u> defines digitized driver's license as a data file available on any mobile device which has connectivity to the internet through an application, which allows the mobile device to download the data file from the department or an authorized representative of the department, which contains all of the data elements visible on the face and back of the physical license and the current status of the license and provides that a copy, photograph, or image of a driver's license not downloaded through the application on a mobile device is not a valid digitized driver's license.

<u>Proposed law</u> prohibits issuance of a citation, in connection with a traffic stop or checkpoint, for driving a motor vehicle without a valid license in his possession if a person presents a digitized driver's license to a law enforcement officer in lieu of a physical driver's license issued by the department.

<u>Proposed law</u> authorizes a law enforcement officer or a representative of the department to require a person to produce the physical driver's license issued by the department, except as provided for in <u>proposed law</u>, and provides that the failure to produce such physical driver's license subjects the person to all applicable laws and consequences for failure to produce such license.

<u>Proposed law</u> requires the department to establish rules necessary to implement a digitized driver's license.

<u>Proposed law</u> specifies that display of a digitized driver's license does not serve as consent or authorization for a law enforcement officer, or any other person, to view, search, or access any other data or application on the mobile device and requires that a law enforcement officer promptly return the mobile device to the person once he has had an opportunity to verify the identity and license status.

<u>Present law</u> requires the secretary of the Dept. of Public Safety and Corrections to issue evidence of renewal of Class "D" or "E" drivers' licenses, which must be affixed to the previously issued license, to indicate the date the license expires in the future when a license is renewed by mail or electronic commerce.

<u>Proposed law</u> modifies <u>present law</u> by requiring the secretary to issue a new license which indicates the new expiration date when a license is renewed by mail or electronic commerce.

## Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Transportation</u>, <u>Highways and Public Works</u> to the <u>original bill</u>:

- 1. Make technical changes.
- 2. Authorize a licensee to have a digitized driver's license provided by the Dept. of Public Safety and Corrections, office of motor vehicles, as an alternative to his physical license.
- 3. Define digitized driver's license as a data file available on any mobile device which has connectivity to the internet through an application, which allows the mobile device to download the data file from the department or an authorized representative of the dept., which contains all of the data elements visible on the face and back of the physical license and the current status of the license and provide that a copy, photograph, or image of a driver's license not downloaded through the application on a mobile device is not a valid digitized driver's license.
- 4. Prohibit the issuance of a citation, in connection with a traffic stop or checkpoint, for driving a motor vehicle without a valid license in his possession if a person presents a digitized driver's license instead of a physical driver's license to a law enforcement officer.
- 5. Authorize a law enforcement officer or dept. representative to require a person to produce the physical driver's license issued by the department, except as provided for in proposed law, and provides that the failure to produce such physical driver's license subjects the person to all applicable laws and consequences for failure to produce such license.
- 6. Require the department to establish rules necessary to implement a digitized driver's license.
- 7. Specify that display of a digitized driver's license to a law enforcement officer, or any other person, does not permit the officer or other person to search, view, or access any other data or application on the mobile device and that the mobile device must be promptly returned to the owner once his identity and license status has been verified.
