1	AN ACT
2	To enact R.S. 49:191(10)(c) and to repeal R.S. 49:191(8)(f), relative to the Department of
3	Veterans Affairs, including provisions to provide for the re-creation of the
4	Department of Veterans Affairs and the statutory entities made a part of the
5	department by law; to provide for the effective termination date for all statutory
6	authority for the existence of such statutory entities; and to provide for related
7	matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. Pursuant to R.S. 49:193, the Department of Veterans Affairs and the
10	statutory entities made a part of the department by law shall be re-created effective June 30,
11	2018, and all statutory authority therefor is continued in accordance with the provisions of
12	Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.
13	Section 2. All statutory authority for the existence of the Department of Veterans
14	Affairs and the statutory entities made a part of the department as re-created by Section 1
15	of this Act shall cease as of July 1, 2023, pursuant to R.S. 49:191. However, the Department
16	of Veterans Affairs may be re-created prior to such date in accordance with the provisions
17	of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.

1	Section 3. The provisions of R.S. 49:193 are hereby superseded to the extent that
2	those provisions are in conflict with the provisions of this Act.
3	Section 4. R.S. 49:191(10)(c) is hereby enacted to read as follows:
4	§191. Termination of legislative authority for existence of statutory entities; phase-
5	out period for statutory entities; table of dates
6	Notwithstanding any termination dates set by any previous Act of the
7	legislature, the statutory entities set forth in this Section shall begin to terminate their
8	operations on July first of each of the following years, and all legislative authority
9	for the existence of any statutory entity, as defined in R.S. 49:190, shall cease as of
10	July first of the following year, which shall be the termination date:

12	(10) July 1, 2022:
13	* * *
14	(c) The Department of Veterans Affairs and all statutory entities made a part
15	of the department by law.
16	Section 5. R.S. 49:191(8)(f) is hereby repealed in its entirety.
17	Section 6. This Act shall become effective on June 30, 2018; if vetoed by the
18	governor and subsequently approved by the legislature, this Act shall become effective on
19	June 30, 2018, or on the day following such approval by the legislature, whichever is later.
