SUPPLEMENTAL PAY: Authorizes DA investigators to be eligible for supplemental pay

AN ACT

2	To amend and reenact R.S. 33:2218.1 and 2218.9 and to enact R.S. 33:2218.3(C) and
3	2218.11, relative to state supplemental pay; to authorize state supplemental pay for
4	certain district attorney investigators; to provide for qualifications of such
5	investigators; to provide for the payment of such supplemental pay; to establish a
6	special treasury fund dedicated to the payments of such funds; to provide for an
7	effective date; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 33:2218.1 and 2218.9 are hereby amended and reenacted and R.S.
10	33:2218.3(C) and 2218.11 are hereby enacted to read as follows:
11	§2218.1. Purpose
12	This law is enacted by the legislature in the exercise of the police power of
13	the state, to promote the public peace and safety, by providing better enforcement of
14	law, and particularly the enforcement of state laws by municipal police officers, and
15	full-time commissioned deputy sheriffs, and district attorney investigators.

17	§2218.3. Special fund
18	* * *
19	C. For the payment of the supplemental salaries provided by R.S.
20	33:2218.11, there is hereby created a special fund in the treasury of the state of

Louisiana, to which the appropriations hereinafter made shall be credited, and the funds so credited shall be and remain dedicated to the payment of such supplemental salaries as provided in R.S. 33:2218.11.

§2218.9. Authorization of back supplemental salary payment

If it is determined by the board of review, as established in this Subpart, that supplemental salaries, as provided for in R.S. 33:2218.2, and R.S. 33:2218.8, and 2218.11, are due eligible recipients for back periods of time, the board shall certify to the Joint Legislative Committee on the Budget that such payment is due. Upon receipt of such certification, the Joint Legislative Committee on the Budget may, in its discretion, approve payment of all or a portion of such supplemental salary from the appropriate special fund created in this Subpart; however, no payment shall be made to any one recipient in excess of ten thousand dollars at any one time.

## §2218.11. Extra compensation for commissioned full-time district attorney investigators of all judicial districts

A. In order to promote the public peace and safety in the state, by providing better enforcement of law and particularly the enforcement of state laws by district attorney investigators, every commissioned district attorney investigator employed on a full-time basis shall be paid by the state extra compensation out of monies appropriated therefor from the fund established by R.S. 33:2218.3(C). For the purposes of this Section, any district attorney investigator hired primarily to perform purely clerical or nonenforcement duties, including but not limited to typists, office machine operators, switchboard operators, filing clerks, stenoclerks, stenographers, animal shelter personnel, school crossing guards, secretaries, cooks, mechanics, and maintenance personnel, whether or not a duly commissioned district attorney investigator or P.O.S.T. certified, shall not be deemed to be a commissioned district attorney investigator entitled to additional compensation out of state funds.

1 B. Out of the funds appropriated by the legislature for the payment of the 2 extra compensation provided by Subsection A of this Section, there shall be 3 distributed to the district attorney of each judicial district monthly to pay additional compensation for full-time commissioned district attorney investigators who have 4 completed and passed a council-approved training program as provided in R.S. 5 40:2405 and who are paid a salary of not less than three hundred fifty dollars per 6 7 month, the amount of five hundred dollars per month for each full-time 8 commissioned district attorney investigator at the completion of one year of service. 9 C. On or before the tenth day of each month, each district attorney in the 10 state shall certify to the state treasurer the number of full-time commissioned 11 investigators in his employ and the number of years of service of each such 12 investigator. Based on the total number of such investigators reported from 13 throughout the state each month and the period of service of such investigators and the amount of monies remaining from the appropriation made therefor, the state 14 15 treasurer shall calculate a monthly allowance to be paid to each such investigator in 16 an amount not to exceed the amounts provided in Subsection B of this Section. The 17 state treasurer shall specify the amount of compensation to be paid to each such 18 investigator and shall remit such sums of money to the district attorney of each 19 judicial district for credit to the district attorney's general fund of the respective 20 districts. Each district attorney shall expend such sums so paid into his district 21 attorney's general fund solely for paying the additional compensation herein 22 provided by granting an allowance in the amount specified by the state treasurer to 23 each full-time commissioned investigator. 24 Section 2. This Act shall become effective on July 1, 2010; if vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on July 1, 25 26 2010, or on the day following such approval by the legislature, whichever is later.

**Abstract:** Authorizes state supplemental pay of \$500 per month to full-time district attorney investigators who receive at least \$350 per month, are P.O.S.T. certified, and who have been employed as a district attorney investigator for at least one year.

<u>Proposed law</u> provides for additional compensation of \$500 per month to every commissioned district attorney investigator employed on a full-time basis who has completed and passed a training program approved by the Council on Peace Officers Standards and Training as provided in R.S. 40:2405, who is paid a salary of not less than \$350 per month, and who has completed one year of service.

<u>Proposed law</u> denies entitlement to state supplemental pay to any district attorney investigator hired primarily to perform purely clerical or nonenforcement duties, whether or not such person is duly commissioned or P.O.S.T. certified. Nonclerical or nonenforcement positions include typists, office machine operators, switchboard operators, filing clerks, stenoclerks, stenographers, animal shelter personnel, school crossing guards, secretaries, cooks, mechanics, and maintenance personnel.

<u>Proposed law</u> provides for the distribution of the additional compensation to the district attorney of each judicial district. Requires each district attorney to certify to the state treasurer the number of full-timed investigators in his employ and the number of years of service of each investigator on or before the 10th day of each month.

<u>Proposed law</u> creates a special fund in the state treasury dedicated to the payment of such supplemental salaries as provided in <u>proposed law</u>.

<u>Present law</u> establishes a board of review for determinations of eligibility of supplemental pay. Provides that when supplemental salaries for municipal police or deputy sheriffs are due to eligible recipients for back periods of time, the board shall certify to the Joint Legislative Committee on the Budget that such payment is due. Authorizes the Joint Legislative Committee on the Budget, in its discretion, to approve payment of all or a portion of such supplemental salaries, not to exceed \$10,000 to any one recipient.

<u>Proposed law</u> applies <u>present law</u> to back pay of supplemental salaries of district attorney investigators.

Effective July 1, 2010.
