Abstract: Prohibits activities involving controlled dangerous substances or other illegal substances on the premises of alcoholic beverage outlets.

<u>Present law</u> prohibits a person holding a retail dealer's permit from permitting the illegal sale, offering for sale, possession, or permitting the consumption of any type of <u>narcotic or habit forming drug</u> on the premises of certain alcoholic beverage outlets.

<u>Present law</u> prohibits a person holding a retail dealer's permit from permitting the illegal sale, offering for sale, possession, or permitting the consumption of any type of <u>controlled</u> dangerous substances on the premises of certain alcoholic beverage outlets.

<u>Proposed law</u> prohibits a person holding a retail dealer's permit from permitting the illegal sale, offering for sale, possession, or permitting the consumption of any type of <u>controlled</u> <u>dangerous substance</u> or other illegal <u>substance</u> on the premises.
