APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment against DOTD in the matter of "Madeline Deeters Campagna and Alberta Deeters Bonnin v. The Succession of Frank Bedell, et al" consolidated with "Leila Marie Tassin, et al v. Frank Bedell, et al"

1	AN ACT
2	To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2011-
3	2012 to be used to pay the judgment in the suit entitled "Madeline Deeters
4	Campagna and Alberta Deeters Bonnin v. the Succession of Frank Bedell, Custom
5	Bus Charters, Inc., represented by its president, Donna BeGovich, and its insurance
6	company, Reliance Insurance Company, Casino Magic Corporation, and the insurers
7	of Frank Bedell, Casino Magic Corporation and State of Louisiana" consolidated
8	with "Leila Marie Tassin, wife of/and Irving C. Tassin, Jr. v. Frank Bedell, Custom
9	Bus Charters, Inc., represented by its president, Donna BeGovich, Casino Magic, and
10	the insurers of Frank Bedell, Custom Bus Charters, Inc. and Casino Magic"; to
11	provide for interest; to provide for court costs; and to provide for related matters.
12	Be it enacted by the Legislature of Louisiana:
13	Section 1. The sum of Fifty-Three Thousand Seven Hundred Thirty and 48/100
14	(\$53,730.48) Dollars, to be apportioned as follows: Twenty-Five Thousand and No/100
15	(\$25,000.00) Dollars each to plaintiffs, Warren Campagna, Sr., as Administrator of the
16	Succession of Madeline Campagna and Shirley Mevers, as the Administratrix of the
17	Succession of Alberta Bonnin, plus Three Thousand Seven Hundred Thirty and 48/100
18	(\$3,730.48) Dollars to plaintiffs for funeral expenses, plus legal interest from August 20,
19	1999, until paid, plus court costs in the amount of One Hundred Twenty One and 75/100
20	(\$121.75) Dollars, is hereby appropriated out of the General Fund of the state of Louisiana

11	Section 2. The judgment provided for in Section 1 hereof shall be deemed to have
12	been paid on the effective date of this Act and legal interest shall cease to run as of that date.
13	Section 3. This Act shall become effective on July 1, 2011; if vetoed by the governor
14	and subsequently approved by the legislature, this Act shall become effective on July 1,
15	2011, or on the day following such approval by the legislature, whichever is later.
