LAW ENFORCE/OFFICERS: Expands the crime of disarming a peace officer to include the taking of all forms of law enforcement equipment

1	AN ACT
2	To amend and reenact R.S. 14:34.6, relative to the crime of disarming a peace officer; to
3	provide for the elements of the crime of disarming a peace officer; to provide for
4	definitions; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 14:34.6 is hereby amended and reenacted and to read as follows:
7	§34.6. Disarming of a peace officer
8	A. (1) Disarming of a peace officer is committed when an offender, through
9	use of force or threat of force, and without the consent of the peace officer, takes
10	possession of a firearm any law enforcement equipment from the person of a peace
11	officer or from an area within the peace officer's immediate control, when the
12	offender has reasonable grounds to believe that the victim is a peace officer acting
13	in the performance of his duty.
14	(2) <u>B.</u> For purposes of this Section:
15	(1) "Law enforcement equipment" shall include any firearms, weapons,
16	restraints, ballistics shields, forced entry tools, defense technology equipment, self-
17	defense batons, self-defense sprays, chemical weapons, or electro shock weapons
18	issued to a peace officer and used in the course and scope of his law enforcement
19	duties.

1	(2) "peace Peace officer" shall include commissioned police officers, sheriffs,
2	deputy sheriffs, marshals, deputy marshals, correctional officers, constables, wildlife
3	enforcement agents, park wardens, and probation and parole officers.
4	$\frac{B}{C}$. Whoever commits the crime of disarming of a peace officer shall be
5	imprisoned at hard labor for not more than five years.

Abstract: Expands the crime of disarming a peace officer to include the taking of all forms of law enforcement equipment.

<u>Present law</u> provides that the crime of disarming a peace officer is committed when an offender, through use of force or threat of force, and without the consent of the peace officer, takes possession of a firearm from the person of a peace officer or from an area within the peace officer's immediate control, when the offender has reasonable grounds to believe that the victim is a peace officer acting in the performance of his duty.

<u>Proposed law</u> retains the elements of the crime but expands the definition to include all law enforcement equipment.

<u>Proposed law</u> defines "law enforcement equipment" as any firearms, weapons, restraints, ballistics shields, forced entry tools, defense technology equipment, self-defense batons, self-defense sprays, chemical weapons, or electro shock weapons issued to a peace officer and used in the course and scope of his law enforcement duties.
